Mr. Coleman Presents Claims Fro Meter Deposit Refunds, NSF Checks, Sales Tax

Mr. Coleman stated that the next item I have is the one you need to sign Doug, it's my copy. It's the one for insufficient funds, meter deposits and monthly sales tax that I give to you each month and that's your copy that is being signed and uh NSF checks is \$353.61 and meter deposit refunds is \$186.92 and monthly sales tax \$1950.78 for a total amount of \$2521.31.

Kendall Coleman/EMC Presents Additional Cost for High Service Pump

Mr. Coleman stated the next item I have is back on January 12th uh the board approved to repair of the high service pump over at the water treatment facility. At that time we had a estimated cost of \$6000.00 uh the first invoice that was received was for the repair of the motor and that was a total cost \$3065.10. We just did receive the invoice for the uh pump itself from Lane. The invoice was for \$4433.30, it puts the expenditure over the estimate, what we expected. Uh what we expected, the total cost was \$7898.40 and at this time I am asking the board to approve the additional expenses and pay the invoice to Lane Western Company in the amount of \$4833.30.

President Eddings stated I'll entertain a motion to pay the invoice from Lane Western Co.

Mr. Coleman stated, it's just an estimate, you don't really know what it's going to be the motor was over run and it took more labor hours than what was anticipated, and the labor hours on the pump itself was higher than what we expected. Those estimates are done from the vendors.

Mr. Coleman stated and Perry I don't know if you've had a chance to tolk about this.

Attorney McCall stated I told them.

Kendall Coleman Addresses EMC Contract Renewal

Mr. Coleman stated what I have is two copies of the contract adendem that was voted on in the last meeting uh those need to be signed, uh the town keeping one original and one original needs to come to me.

President Eddings stated ok we also need to pass and ordinance to adopt the contract for a period on one year, but, we can sign the agreement.

Attorney McCall stated you already approved it, just go ahead and sign the agreement today and then make it retroactive ordinance next meeting.

Mr. Coleman stated the next item I have is there have been some concerns that uh myself and some of the staff it has been difficult to contact us and I have for the board members all I'm giving out here is a list of staff, my business card uh, home phone, pager numbers, mobile phone, along with the water superintendent, all the employees at the, both utilities, and at the bllling office and then some of the emergency numbers that go along with that. It just for your own records.

President Eddings stated, very good.

Kendall Coleman/EMC Addresses Money Collected for Water Taps

Mr. Coleman stated and the last item, clarification maybe more from Perry for the board. Since I took over in Novemberthe materials have been purchased for water taps is being paid for out of our maintenance and repair fund. Installation and service really isn't a maintenance and repair expenditure uh, from my understanding from a former utility manager that those items were passed through in the past to the town and paid for out of the tap fund. Aind I know since November the town has collected almost twelve thousand dollars in water taps and we buy those materials we're paying for that out of our maintenance repair fund. The reason I bring that up is the reason I caught it and done some research I'm running about 15,000.00 over our maintenance and repairfund right now and I expect to be over budget ar the end of contract year about 18000.00.

President Eddings stated it just seem reasonable to me the tap-ins should cover the cost of.

Mr. Coleman stated in looking at the purposal and looking at the contract there is no language that says anything about water taps. It says maintenance repair items.

Vice-President Broady stated, how did it get off in that in the first place?

Mr. Coleman stated I don't know I wish I had an answer. Tom said that there was an agreement with the board, it was a verbal agreement, an verbal agreement doesn't hold much water, and he said at the time that we negotiated the contract we sat down and finalized the contract that an agreement that all expenditures that was related to water would be paid for out of water tap expenditures, which is what that fund is set up for.

President Eddings stated would anyone like to make a motion to cover the material cost out of the tap in fees instead of the.

Council Member Alexander stated yes, we're talking about the future.

Mr. Coleman stated, an example is the nursing home that is being built on Hwy 60, the cost right now are around 1800.00.

Attorney McCall stated would you want to amend the contract and a amendment to the contract to cover that issue?

Mr. Coleman stated, Perry, that is what I want to know, that's why I'm asking.

Attorney McCall stated well the only reason I'm saying that simply because the contract

ORDINANCE NO. 98-690 AN ORDINANCE AMENDING ORDINANCE NO. 92-519 FOR REFUSE AND GARBAGE REGULATIONS WITHIN THE TOWN OF SELLERSBURG

WHEREAS, the Town Council for the Town of Sellersburg did on February 24, 1992, pass Ordinance No. 92-519 which set forth the regulations for garbage and refuse within the Town of Sellersburg town limits; and

WHEREAS, the Town Council for the Town of Sellersburg determined that amendment to said ordinance is necessary to effectuate proper refuse and garbage collection for all residents of the Town of Sellersburg;

WHEREAS, the Town Council for the Town of Sellersburg has determined that said amendment to the ordinance is necessary for efficient and effective administration of Town Government;

WHEREAS, the Town Council for the Town of Sellersburg has considered this matter in an open meeting in which the public were invited to attend and participate:

BE IT NOW THEREFORE ORDAINED AS FOLLOWS:

Section 6-97 of Article 9 of the Sellersburg Town Code shall be amended as follows.

The Town of Sellersburg shall provide refuse and garbage collection to multiple housing units which have no more than eight (8) units per parcel and have single meters for each such unit.

Each unit shall be limited to only two (2) thirty- gallon garbage cans.

The Town shall assess a fee of three (\$3.00) dollars per month to each dwelling unit for said service which shall be billed directly to the occupant on the monthly billing statement for which

Refuse and garbage collection under this ordinance does not include yard waste collection.

All other provisions of said ordinance shall remain in full force and affect.

AN ORDINANCE AMENDING ORDINANCE NO. 95-615, REGARDING THE INDIANA MODEL ORDINANCE FOR FLOOD HAZARD AREAS

WHEREAS, the Town Council for the Town of Sellersburg, Indiana, did on the 13th day of February, 1995, adopt Ordinance No. 95-615, regarding the Indiana Model Ordinance for Flood Hazard Areas; and

WHEREAS, the Town Council for the Town of Sellersburg has been informed by the Indiana Department of Natural Resources that said Ordinance No. 95-615 contains various information which must be corrected; and

WHEREAS, the Town Council for the Town of Sellersburg, Indiana, has determined in an open meeting in which the public was allowed to participate, that Ordinance No. 95-615 should be amended to reflect the changes requested by the Indiana Department of Natural Resources.

Be it ordained by the Town Board of the Town of Sellersburg, Indiana as follows:

<u>SECTION 1. STATUTORY AUTHORIZATION.</u> The Indiana Legislature granted the power to local units of government (I.C. 36-7-4) to control land use within their jurisdictions in order to accomplish the following.

SECTION 2.. STATEMENT OF PURPOSE. The purpose of this ordinance is to guide development in the flood hazard areas in order to reduce the potential for loss of life and property, reduce the potential for health and safety hazards, and to reduce the potential for extraordinary public expenditures for flood protection and relief. Under the authority granted to local units of government to control land use within their jurisdiction, which includes taking into account the effects of flooding, the Sellersburg Town Board of Trustees hereby adopts the following floodplain management regulations in order to accomplish the following:

- a. To prevent unwise developments from increasing flood or drainage hazards to others;
- b. To protect new building and major improvements to buildings from flood damage;
- c. To protect human life and health from the hazards of flooding;
- d. To lessen the burden on the taxpayer for flood control projects, repairs to flood-damaged public facilities and utilities, and flood rescue and relief operations;
- e. To maintain property values and a stable tax base by minimizing the potential for creating flood blighted areas; and

To make federally subsidized flood insurance available for property in the Town of Sellersburg by fulfilling the requirements of the National Flood Insurance Program.

<u>SECTION 3. DEFINITIONS.</u> For the purpose of this ordinance, the following definitions are adopted:

- a. Building see "structure".
- Development any man-made change to improved or unimproved real estate including, but not limited to:
 - 1. Construction, reconstruction, or placement of a building or any addition to a building;
 - 2. Installing a manufactured home on a site for a manufactured home or installing a recreational vehicle on a site for more than 180 days;
 - 3. Installing utilities, erection of walls and fences, construction of roads, or similar projects;
 - 4. Construction of flood control structures such as levees, dikes, dams, channel improvements, etc.;
 - 5. Mining, dredging, filling, grading, excavation, or drilling operations;
 - 6. Construction and/or reconstruction of bridges or culverts;
 - 7. Storage of materials; or
 - 8. Any other activity that might change the direction, height, or velocity of flood or surface waters.

"Development" does not include activities such as the maintenance of existing buildings and facilities such as painting, re-roofing, resurfacing roads, or gardening, plowing, and similar agricultural practices that do not involve filling, grading, excavation, or the construction of permanent buildings.

Existing manufactured home park or subdivision - means a manufactured home park or subdivision for which the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including, at a minimum, the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads) is

Page 11. completed before the effective date of the floodplain management regulations adopted by a community.

- d. Expansion to an existing manufactured home park or subdivision means the preparation of additional sites by the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads).
- e. FHBM means Flood Hazard Boundary Map.
- f. FIRM means Flood Insurance Rate Map.
- g. FBFM Flood Boundary and Floodway Map.
- h. FEMA Federal Emergency Management Agency.
- i. Flood a general and temporary condition of partial or complete inundation of normally dry land areas from the overflow, the unusual and rapid accumulation, or the runoff of surface waters from any source.
- j. Floodplain the channel proper and the areas adjoining any wetland, lake or watercourse which have been or hereafter may be covered by the regulatory flood. The floodplain includes both the floodway and the floodway fringe districts.
- k. Flood Protection Grade or the "FPG" means the elevation of the regulatory flood plus two feet at any given location in the Special Flood Hazard Area (SFHA).
- 1. Floodway means the channel of a river or stream and those portions of the floodplains adjoining the channels which are reasonably required to efficiently carry and discharge the peak flood flow of the regulatory flood of any river or stream.
- m. Floodway Fringe means those portions of the flood hazard areas lying outside the floodway.
- n. Letter of Map Amendment (LOMA) An amendment to the currently effective FEMA map that establishes that a property is not located in a SFHA. A LOMA is only issued by FEMA.
- o. Letter of Map Revision (LOMR) An official revision to the currently effective FEMA map. It is issued by FEMA and changes flood zones, delineations, and elevations.
- p. Lowest Floor means the lowest of the following:

Page 12. 1. The top of the basement floor;

- 2. The top of the garage floor, if the garage is the lowest level of the building;
- 3. The top of the first floor of building elevated on pilings or constructed on a crawl space with permanent openings; or
- 4. The top of the floor level of any enclosure below an elevated building where the walls of the enclosure provide any resistance to the flow of flood waters unless:
 - (a) The walls are designed to automatically equalize the hydrostatic flood forces on the walls by allowing for the entry and exit of flood waters, through providing a minimum of two openings (in addition to doorways and windows) having a total area of one (1) square foot for every two (2) square feet of enclosed floor area subject to flooding. The bottom of such openings shall be no higher than one (1) foot above grade.
 - (b) Such enclosed space shall be usable for the parking of vehicles and building access.
- q. Manufactured Home means a structure, transportable in one or more sections, which is built on a permanent chassis and is designed for use with or without a permanent foundation when attached to the required utilities. The term "manufactured home" does not include a "recreational vehicle".
- r. New manufactured home park or subdivision means a manufactured home park or subdivision for which the construction of facilities for servicing the lots on which the manufactured homes are to be affixed (including at a minimum, the installation of utilities, the construction of streets, and either final site grading or the pouring of concrete pads) is completed on or after the effective date of floodplain management regulations adopted by a community.
- Recreation Vehicle means a vehicle which is (1) built on a single chassis; (2) 400 square feet or less when measured at the largest horizontal projections; (3) designed to be self-propelled or permanently towable by a light duty truck; and (4) designed primarily not for use as a permanent dwelling, but as temporary living quarters for recreational camping, travel, or seasonal use.
- t. Regulatory Flood means the flood having a one percent probability of being equaled or exceeded in any given year, as calculated by a method and procedure which is acceptable to and approved by the Indiana Natural Resources Commission. The regulatory flood elevation at any location is as defined in Section 5 of this ordinance. The "Regulatory Flood" is also known by the term "Base Flood".

- u. SFHA or Special Flood Hazard Area means those lands within the jurisdiction of the Town that are subject to inundation by the regulatory flood. The SFHAs of the Town are generally identified as such on the Flood Insurance Rate Map of the Town prepared by the Federal Emergency Management Agency and dated August 1, 1980. The SFHAs of those parts of unincorporated Clark County that are within the extraterritorial jurisdiction of the Town or that may be annexed into the Town are generally identified as such on the Flood Insurance Rate Map prepared for Clark County by the Federal Emergency Management Agency and dated February 18, 1983.
- v. Structure means a structure that is principally above ground and is enclosed by walls and a roof. The term includes a gas or liquid storage tank, a manufactured home, or a prefabricated building. The term also includes recreational vehicles and travel trailers to be installed on a site for more than 180 days.
- w. Substantial Improvement means any reconstruction, rehabilitation, addition, or other improvement of a structure, the cost of which equals or exceeds 50 percent of the market value of the structure before the "start of construction" of the improvement. This term includes structures which have incurred "substantial damage" regardless of the actual repair work performed. The term does not include improvements of structures to correct existing violations of state or local health, sanitary, or safety code requirements or any alteration of a "historic structure", provided that the alteration will not preclude the structures continued designation as a "historic structure".

SECTION 4. DUTIES OF THE ADMINISTRATOR. The Building Inspector for the Town of Sellersburg shall implement this ordinance and hereafter be referred to as the Zoning Administrator. The Zoning Administrator for the Town of Sellersburg is appointed to review all development and subdivision proposals to insure compliance with this ordinance, including but not limited to the following duties:

- a. Ensure that all development activities within the SFHAs of the jurisdiction of the Town meet the requirements of this ordinance.
- b. Provide information and assistance to citizens upon request about permit procedures and floodplain construction techniques.
- c. Ensure that construction authorization has been granted by the Indiana Natural Resources Commission for all development projects subject to Section 7 of this ordinance, and maintain a record of such authorization (either copy of actual permit or letter of recommendation).

- dage 1 Maintain a record of the "as-built" elevation of the lowest floor (including basement) of all new and/or substantially improved buildings constructed in the SFHA. Inspect before, during and after construction.
- e. Maintain a record of the engineer's certificate and the "as-built" floodproofed elevation of all buildings subject to Section 8 of this ordinance.
- f. Cooperate with state and federal floodplain management agencies to improve base flood and floodway data and to improve the administration of this ordinance. Submit reports as required for the National Flood Insurance Program.
- g. Maintain for public inspection and furnish upon request regulatory flood data, SFHA maps, Letters of Map Amendment (LOMA), Letters of Map Revision (LOMR), copies of DNR permits and letters of recommendation, federal permit documents, "as-built" elevation and floodproofing data, and all buildings constructed subject to this ordinance.
- h. Notify adjacent communities and State Coordinating Office prior to any alteration or relocation of a watercourse, and submit copies of such notifications to FEMA.

<u>SECTION 5. REGULATORY FLOOD ELEVATION.</u> This ordinance's protection standard is the regulatory flood. The best available regulatory flood data is listed below. Whenever a party disagrees with the best available data, the party submitting the detailed engineering study needs to replace existing data with better data and submit it to the Department of Natural Resources for review and approval.

- a. The regulatory flood elevation and floodway limits for the SFHAs of Muddy Fork Creek and Silver Creek shall be as delineated on the 100 year flood profiles in the Flood Insurance Study of the Town dated February, 1980, and corresponding FIRM dated August 1, 1980, prepared by the Federal Emergency Management Agency.
- b. The regulatory flood elevation for each SFHAs delineated as an "AH Zone" or an "AO Zone" shall be that elevation (or depth) delineated on the Flood Insurance Rate Map of the Town.
- The regulatory flood elevation for each of the remaining SFHAs delineated as an "A Zone" in the Flood Insurance Rate Map of the Town shall be according to the best data available as provided by the Department of Natural Resources.
- d. The regulatory flood elevation and floodway limits for the SFHAs of those parts of unincorporated Clark County that are within the extraterritorial jurisdiction of the Town or that may be annexed into the Town shall be delineated on the 100 year flood profiles in the Flood Insurance Study of Clark County prepared by the Federal Emergency Management Agency and dated March, 1980, and the corresponding FBFM dated September 30, 1980, prepared by FEMA.

e. If the SFHA is delineated as an "AH Zone or AO Zone", the elevation (or depth) will be delineated on the County Flood Insurance Rate Map. If the SFHA is delineated as "Zone A" on the County Flood Insurance Rate Map, the regulatory flood elevation shall be according to the best data available as provided by the Department of Natural Resources.

<u>SECTION 6. IMPROVEMENT LOCATION PERMIT.</u> No person, firm, corporation, or governmental body not exempted by state law shall commence any "Development" in the SFHA without first obtaining an Improvement Location Permit from the Town Zoning Board. The Zoning Board shall not issue an Improvement Location Permit if the proposed "Development" does not meet the requirements of this ordinance.

- a. The application for an Improvement Location Permit shall be accompanied by the following:
 - 1. A description of the proposed development.
 - 2. Location of the proposed development sufficient to accurately locate property and structure in relation to existing roads and streams.
 - 3. A legal description of the property site.
 - 4. A site development plan showing existing and proposed structure locations and existing and proposed land grades.
 - 5. Elevation of lowest floor (including basement) of all proposed structures. Elevation should be in National Geodetic Vertical Datum of 1929 (NGVD).
- b. Upon receipt of an application for an Improvement Location Permit, the Zoning Administrator shall determine if the site is located within an identified floodway or within the floodplain where the limits of the floodway have not yet been determined.
 - 1. If the site is in an identified floodway, the Zoning Administrator shall require the applicant to forward the application, along with all pertinent plans and specifications, to the Department of Natural Resources and apply for a permit for construction in a floodway.

Under the provisions of IC 14-28-1, a permit from the Natural Resources Commission is required prior to the issuance of a local building permit for any excavation, deposit, construction or obstruction activity located in the floodway. This includes land preparation activities such as filling, grading, clearing and paving, etc. undertaken before the actual start of construction of the building.

Sellersburg Town Council Regular Meeting May 11, 1998 Page 16.

No action shall be taken by the Zoning Administrator until a permit has been issued by the Natural Resources Commission granting approval for construction in the floodway. Once a permit has been issued by the Natural Resources Commission, the Zoning Administrator may issue the local Improvement Location Permit, provided the provisions contained in Sections 7 and 8 of this ordinance have been met. The Improvement Location Permit cannot be less restrictive than the permit issued by the Natural Resources Commission.

- If the site is located in an identified floodway fringe, then the Zoning Administrator may issue the local Improvement Location Permit provided the provisions contained in Section 7 and 8 of this ordinance have been met. The key provision is that the lowest floor of any new or substantially improved structure shall be at or above the Flood Protection Grade.
 - 3. If the site is in an identified floodplain where the limits of the floodway and floodway fringe have not yet been determined (shown as Zone A on the Flood Insurance Rate Map), and the drainage area upstream of the site is greater than one square mile, the Building Official shall require the applicant to forward the application, along with all pertinent plans and specifications, to the Department of Natural Resources for review and comment.

No action shall be taken by the Zoning Administrator until either a permit for construction in the floodway or a letter of recommendation citing the 100 year flood elevation and the recommended Flood Protection Grade has been received from the Department of Natural Resources.

Once the Zoning Administrator has received the proper permit or letter of recommendation approving the proposed development, an Improvement Location Permit may be issued provided the conditions of the ILP are not less restrictive than the conditions received from Natural Resources and the provisions contained in Section 7 and 8 of this ordinance have been met.

4. If the site is in an identified floodplain where the limits of the floodway and floodway fringe have not yet been determined and the drainage area upstream of the site is less than one square mile, the Zoning Administrator shall require the applicant to provide an engineering analysis showing the limits of the floodway, floodway fringe and 100 year flood elevation of the site. Upon receipt, the Zoning Administrator may issue the local Improvement Location Permit, provided the provisions contained in Section 7 and 8 of this ordinance have been met.

<u>SECTION 7. PREVENTING INCREASED DAMAGES.</u> No development in the SFHA shall create a damaging or potentially damaging increase in flood heights or velocity or threat to public health and safety.

- a. Within the floodway identified on the Flood Boundary and Floodway Map or the Flood Insurance Rate Map, or engineering analysis as provided in Section 6.6.4., the following standards shall apply:
 - 1. No development shall be allowed which acting alone or in combination with existing or future similar works, will cause <u>any</u> increase in the elevation of the regulatory flood; and
 - 2. For all projects involving channel modifications or fill (including levees), the Town shall submit a request to the Federal Emergency Management Agency to revise the regulatory flood data.
- b. Within all SFHAs identified as A Zones (no 100 year flood elevation and/or floodway/floodway fringe delineation has been provided), the following standard shall apply:
 - The total cumulative effect of the proposed development, when combined with all other existing and anticipated development, will not increase the regulatory flood elevation more than one-tenth (0.1) of one foot and will not increase flood damages or potential flood damages.
- c. Public Health Standards in all SFHAs:
 - No development in the SFHA shall include locating or storing chemicals, explosives, buoyant materials, flammable liquids, pollutants, or other hazardous or toxic materials below the Flood Protection Grade, unless such materials are stored in floodproofed tanks or floodproofed buildings constructed according to the requirements of Section 8 of this ordinance.
 - 2. New and replacement sanitary sewer lines and on-site waste disposal systems may be permitted provided all manholes or other above ground openings located below the FPG are watertight.

<u>SECTION 8. PROTECTING BUILDINGS.</u> In addition to the damage prevention requirements of Section 7, all buildings to be located in the SFHA shall be protected from flood damage below the FPG.

- a. This building protection requirement applies to the following situations:
 - 1. Construction or placement of any new building having a floor area greater than 400 square feet.

- 2. Structural alterations made to an existing building that increase the market value of the building by more than 50% (excluding the value of the land) or any structural alteration made previously (one time only alteration);
- 3. Any subsequent alterations;
- 4. Reconstruction or repairs made to a damaged building that are valued at or more than 50% of the market value of the building (excluding the value of the land) before damage occurred.
- 5. Installing a manufactured home on a new site or a new manufactured home on an existing site. This ordinance does not apply to returning the existing manufactured home to the same site is lawfully occupied before it was removed to avoid flood damage; and
- 6. Installing a travel trailer or recreational vehicle on a site for more than 180 days.
- b. This building protection requirement may be met by one of the following methods. The Building Official shall maintain a record of compliance with these building protection standards as required in Section 4 of this ordinance.
 - 1. A residential or nonresidential building may be constructed on a permanent land fill in accordance with the following:
 - (a) The fill shall be placed in layers no greater than one foot deep before compacting to 95% of the maximum density obtainable with the Standard Proctor Test method.
 - (b) The fill should extend at least ten feet beyond the foundation of the building before sloping below the FPG.
 - (c) The fill shall be protected against erosion and scour during flooding by vegetative cover, riprap, or bulkheading. If vegetative cover is used, the slopes shall be no steeper than 3 horizontal to 1 vertical.
 - (d) The fill shall not adversely affect the flow of surface drainage from or onto neighboring properties.
 - (e) The top of the lowest floor (see definition of lowest floor in Section 3. Definitions) shall be at or above the FPG.
 - 2. A residential or nonresidential building may be elevated in accordance with the following:

- (a) The building or improvements shall be elevated on posts, piers, columns, extended walls, or other types of similar foundations provided:
 - (1) Walls of any enclosure below the elevated floor shall be designed to automatically equalize hydrostatic flood forces on the walls by allowing for the entry and exit of flood waters, through providing a minimum of two openings (in addition to doorways and windows) having a total area of one (1) square foot for every two (2) square feet of enclosed floor area subject to flooding. The bottom of all such openings shall be no higher than one (1) foot above grade.
 - (2) Any enclosure below the elevated floor is used for storage of vehicles and building access.
- (b) The foundation and supporting members shall be anchored and aligned in relation to flood flows and adjoining structures so as to minimize exposure to known hydrodynamic forces such as currents, waves, ice, and floating debris.
- All areas below the FPG shall be constructed of materials resistant to flood damage. The top of the lowest floor (including basement) and all electrical, heating, ventilating, plumbing, air conditioning equipment and utility meters shall be located at or above the FPG. Water and sewer pipes, electrical and telephone lines, submersible pumps, and other waterproofed service facilities may be located below the FPG.
- 3. Manufactured homes and travel trailers (also called recreational vehicles) to be installed substantially improved on site for more than 180 days must meet one of the following anchoring requirements:
 - (a) The manufactured home shall be elevated on a permanent foundation such that the lowest floor shall be at or above the FPG and securely anchored to an adequately anchored foundation system to resist flotation, collapse, and lateral movement. This requirement applies to all manufactured homes to be placed on a site;
 - (1) Outside a manufactured home park or subdivision;
 - (2) In a new manufactured home park or subdivision;
 - (3) In an expansion to an existing manufactured home park or subdivision; or

- (4) In an existing manufactured home park or subdivision on which a manufactured home has incurred "substantial damage" as a result of a flood.
- (b) The manufactured home shall be elevated so that the lowest floor of the manufactured home chassis is supported by reinforced piers or other foundation elements that are no less than 36 inches in height above grade and be securely anchored to an adequately anchored foundation system to resist flotation, collapse, and lateral movement.

This requirement applies to all manufactured homes to be placed on a site in an existing manufactured home park or subdivision that has not been substantially damaged by a flood.

- 4. Recreation vehicles placed on a site shall either:
 - (a) Be on the site for less than 180 consecutive days;
 - (b) Be fully licensed and ready for highway use (defined as being on its wheels or jacking system, is attached to the site only by quick disconnect type utilities and security devices, and has no permanently attached additions); or
 - (c) Meet the requirements for "manufactured homes" in Paragraph 3 of this section.
- 5. A non-residential building may be floodproofed to the FPG (in lieu of elevating) if done in accordance with the following:
 - (a) A Registered Professional Engineer shall certify that the building has been designed so that below the FPG, the structure and attendant utility facilities are watertight and capable of resisting the effects of the regulatory flood. The building design shall take into account flood velocities, duration, rate of rise, hydrostatic pressures, and impacts from debris or ice.
 - (b) Floodproofing measures shall be operable without human intervention and without an outside source of electricity.

SECTION 9. OTHER DEVELOPMENT REQUIREMENTS.

a. The Planning Commission shall review all proposed subdivisions to determine whether the subdivision lies in a flood hazard area as defined elsewhere by ordinance. If the (review agency or official) finds the subdivision to be so located, the (review agency or individual)

shall forward plans and materials to the Indiana Department of Natural Resources for review and comment. The (review agency or individual) shall require appropriate changes and modifications in order to assure that:

- 1. It is consistent with the need to minimize flood damages;
- 2. All public utilities and facilities, such as sewer, gas, electrical, and water systems are located and constructed to minimize or eliminate flood damage;
- 3. Adequate drainage is provided so as to reduce exposure to flood hazards;
- 4. On-site waste disposal systems, if provided, will be so located and designed to avoid impairment of them or contamination from them during the occurrence of the regulatory flood.
- b. Developers shall record the 100 year flood elevation on all subdivision plats containing lands identified elsewhere by ordinance as within a flood hazard area prior to submitting the plats for approval by the Plan Commission.
- c. All owners of manufactured home parks or subdivisions located within the SFHA, identified as Zone A on the community's FHMB or FIRM, develop an evacuation plan for those lots located in Zone A and file it with the local Plan Commission and have it filed and approved by the appropriate community emergency management authorities.

SECTION 10: VARIANCES

- a. The Board of Zoning Appeals may consider issuing a variance to the terms and provisions of this ordinance provided the applicant demonstrates that:
 - 1. There exists a good and sufficient cause for the requested variance;
 - 2. The strict application of the terms of this ordinance will constitute an exceptional hardship to the applicant; and
 - 3. The granting of the requested variance will not increase flood heights, create additional threats to public safety, cause additional public expense, create nuisances, cause fraud or victimization of the public, or conflict with existing laws or ordinances.
- b. The Board of Zoning Appeals may issue a variance to the terms and provisions of this ordinance subject to the following standards and conditions:

- No variance or exception for a residential use within a floodway subject to Section 7 (a) or (b) may be granted;
- 2. Any variance or exception granted in a floodway subject to Section 7 (a) or (b) will require a permit from Natural Resources;

Payer Torrest

- 3. Variances or exceptions to the Building Protection Standards of Section 8 may be granted only when a new structure is to be located on a lot of one-half acres or less in size, contiguous to and surrounded by lots with existing structures constructed below the flood protection grade;
- 4. Variances or exception may be granted for the reconstruction or restoration of any structure individually listed on the Register of Historic Places or the Indiana State Survey of Historic Architectural, Archaeological and Cultural Sites, Structures, Districts, and Objects;
- 5. All variances shall give the minimum relief necessary and be such that the maximum practical flood protection will be given to the proposed construction; and
- 6. The Board of Zoning Appeals shall issue a written notice to the recipient of a variance or exception that the proposed construction will be subject to increased risks to life and property and could require payment of excessive flood insurance premiums.

SECTION 11. DISCLAIMER OF LIABILITY. The degree of flood protection required by this ordinance is considered reasonable for regulatory purposes and is based on available information derived from engineering and scientific methods of study. Larger floods can and will occur on rare occasions. Therefore, this ordinance does not create any liability on the part of the community, Natural Resources, or the State of Indiana, for any flood damage that results from reliance on this ordinance or any administrative decision made lawfully thereunder.

SECTION 12. VIOLATIONS. Failure to obtain an Improvement Location Permit in the SFHA or failure to comply with the requirements of a permit or conditions of a variance shall be deemed to be a violation of this ordinance. All violations shall be considered a common nuisance and be treated as such in accordance with the provisions of the Zoning Code for the Town of Sellersburg. All violations shall be punishable by a fine not exceeding \$_____

- a. A separate offense shall be deemed to occur for each day the violation continues to exist.
- b. The Sellersburg Zoning and Planning Commission shall inform the owner that any such violation is considered a willful act to increase flood damages and therefore may cause coverage by a Standard Flood Insurance Policy to be suspended.

c. Nothing herein shall prevent the Town from taking such other lawful action to prevent or remedy any violations. All costs connected therewith shall accrue to the person or persons responsible.

SECTION 13. ABROGATION AND GREATER RESTRICTIONS. This ordinance repeals and replaces other ordinances adopted by the Town Council to fulfill the requirements of the National Flood Insurance Program. However, this ordinance does not repeal the original resolution or ordinance adopted to achieve eligibility in the Program. Nor does this ordinance repeal, abrogate, or impair any existing easements, covenants, or deed restrictions. Where this ordinance and other ordinance easements, covenants, or deed restrictions conflict or overlap, whichever imposes the more stringent restrictions shall take precedence.

<u>SECTION 14. SEPARABILITY.</u> The provisions and sections of this ordinance shall be deemed separable and the invalidity of any portion of this ordinance shall not affect the validity of the remainder.

<u>SECTION 15. EFFECTIVE DATE.</u> This ordinance shall take effect upon its passage by the Town Council.

RESOLUTION OF THE SELLERSBURG TOWN COUNCIL

Comes now the Town of Sellersburg, by its council members, on the $\frac{1}{2}$ day of $\frac{1998}{2}$ and hereby passes the following resolution:

WHEREAS, the Town of Sellersburg on the 25th day of September, 1989 conveyed and warranted unto the Sellersburg Fire Protection District a certain tract of land as stated in Deed Drawer 21, Instrument No. 10221 of the Recorder's Office of Clark County, Indiana.

WHEREAS, said Warranty Deed conveying this property contained a provision wherein if the property were to ever cease being used for the purpose of actively providing the Town of Sellersburg fire protection services, then said property shall automatically revert back to the Town of Sellersburg and the Sellersburg Fire Protection District shall have no ownership interest in said property.

WHEREAS, the Sellersburg Volunteer Fire Department has leased said property from the Sellersburg Fire Protection District for a period of fifty (50) years.

WHEREAS, the Sellersburg Volunteer Fire Department desires to pledge an assignment of its Lease of said premises for securement of a loan with the Liberty National Bank.

WHEREAS, the Sellersburg Fire Protection District has provided its consent to the pledge of an assignment of said Lease Agreement for security of said loan and now seeks the approval of the Town of Sellersburg of a waiver of the reverter clause as contained in the Warranty Deed specifically for the benefit of the Liberty National Bank and limited to this transaction and only for the duration of said debt obligation by the Sellersburg Volunteer Fire Department to the Liberty National Bank.

WHEREAS, it is in the best interest of the Town of Sellersburg to facilitate the advancement of its fire protection services and the granting of such a waiver will directly benefit the ability of the Sellersburg Volunteer Fire Department to provide fire protection services to the Town of Sellersburg.

WHEREAS, this Resolution is specifically and expressly contingent upon the Fire District's re agreement that they will be responsible for directly making the payment themselves to the Liberty National Bank for this loan. It is therefore,

RESOLVED that the Town of Sellersburg by and through its Town Council, hereby passes this resolution stating that the reverter clause as contained in the Warranty Deed as recorded in the Deed Drawer 21, Instrument 10221 of the Clark County Recorder's Office, is expressly waived for the purposes of permitting the Sellersburg Volunteer Fire Department to pledge an

JOAN HICKS ADDRESSES THE COUNCIL MEMBERS CONCERNING THE DRAINAGE DITCH BEHIND HER HOUSE.

President Eddings just come up to the board.

Mrs. Hicks stated ok I've come to ask someone to look at the drainage system in the back of my property which is actually in the property of Hamstead Heath. There is a drainage ditch which there is a lot of work going on in Hill-N-Dale in other places. This has at one point was a ditch and now it's now barely a trinkle trench. It is constantly filled with mosquito's and this has been an ongoing problem for the twelve years that I've lived there. I had talked with someone here at the Town Hall or in the Town Office, I believe it was Mark and he said that he was not going to do anything. I spent time at the courthouse trying to find out where the storm drains go. There's nothing on the plats or in the recorded paperwork from the developer, and at this time I can't assertain that Sellersburg has anything showing the storm drain or not. What we do have is with all the problems that they have in Hamstead Heath they have got four drains two of them on Hampton Court that run under the street that feed into two drains that go from one side of Regents Park to the other side which would be on the north end, flows through a pipe that stops at the last, at the very first lot on that end. The next two flows into an open ditch which then feeds into a storm drainage ditch that runs between 713 and 719 Alabama and runs under the street. Over a course of time this ditch has been aroding and as I said it was a ditch at one point now there are place's that are less than a trench. You might have two inches to five inches. And it's just a constant breeding ground for mosquito's and anything else that decides to live there. In the mean time, I mean I have just two months ago had a drainage system in my basement where all the water was coming across my property. And I have been told by contractors this was ten years ago that which each basement that was built in Hamstead Heath it moved the water table. And I mean at this point I'm concerned about getting this drainage ditch taken care of feeding the water flowing it away and taking care of the mosquito's. I can't let my kinds or myself out in the backyard and the one couple that I do know that lives on the adjoining property on Hampton Court I've been at their house just as it's going to be about dusk and the mosquito's are so bad in their front or back yard that you can't go outside. And I'd like somehow, somebody to tell me where I go? Or what needs to be done.

Council Member Alexander stated where exactly are you talking about?

President Eddings stated 709 Alabama.

Council Member Alexander stated I know where is it in the backyard?

Mrs. Hicks stated yes this is Hamstead ok I'm trying to look at here's Regents here are the street drains. Here's the two that are on Hampton Court that feed back in: There is a street drain here and here this pipe. There is a drainage pipe here. It stops at the corner of this property. This at one time was a ditch. It's suppose to be a ditch and then from that point it runs between 713 and 719 Alabama.

STEVE WELCH ADDRESSES THE COUNCIL.

Mr. Welch stated uh, Mr. Eddings I have a question. I heard him mention the name of Gray Fox construction and the man that is the construction, that is the manager of that company and man named Trindad uh, Ordondo uh he came by to see us last Wednesday and said that they may have to completely redo the receptales in our yard. He said it was done wrong and I'm not going to lie to you he said these things, are a good eight inches higher than they're supposed to be. Somehow we've got to cut this off and this may involve taking them up out of the ground. And them cutting them off and this may involve taking them up out of the ground. And then cutting them off and sitting them back down again. They have to be redone. Also while we're on the topic this last big rain we had, I believe it was over the weekend on Sunday, I called Ken Alexander and made him aware of the problem right in behind us water was flowing over New Albany Street and boiling up out of the sewer. It's actually on the what used to be Mr. Fry's property and now he has since sold it. But this water was boiling up out of the sewer and coming over both sides on New Albany Street. It looked like it was coming from all the way over on Maple Drive. It circulated around to the back of our garage and completely flooded our garage and back yard. And for all the noise that they have been making, all this digging and everything, its still not done. The excuativing, the great big sinkhole in our yard and everything they have not solved the water drainage problem. There is something going on over on New Albany Street and futher over than that. Because we pulled in our drive we was in Clarksville when the storm hit, we pulled up in the drive and we were just stunned the water was boiling out of the sewer cap and after it finaly receded I went over there and the sewer cap on Fry's property is tiny compared to what's in our yard. It's entirely to small and perhaps that the problem. It's not a large enough hold on this water. The water was just flowing across New Albany Street.

President Eddings stated ok, we'll have to take a look at that to see if something can't be done. To see if there's something being backed up or what's going on. Ok, alright Gary.

COUNCIL MEMBER FENNER ADDRESSES THE COUNCIL/POOL.

Council Member Fenner stated uh, we the pool is up and running. It looks better than it has in years and we do have a problem with a leak that we're going to be working on but hopefully it won't affect the operation of the pool this year. We will be looking at some expense to fix it, hopefully it won't be till after the season is over with. Uh, also we have been working with the Korean War Veterns in Wilkerson Park and trying to make several inprovements there. We're replacing some lights, we didn't even have any lights on the flag pole at all and put a light on the flag and we're doing several other things along with them in preparation for July the 4th when they will unveil and dedicate the Korean War Memorial. And so we are glad for that. Then also I have been talking with the people from Tarc. Uh last year I think it was they came and talked to us about establishing a route in Sellersburg and that is to take place. It is all set, it will begin June the 15th and there will be a ribbion cutting cermoney in front of the Town Hall. It will be at ll o'clock in the morning and they have invited us, as a Town Council to come a be a part of that. They, it will run from Monday through Friday from 6 a.m. to approxmialey 6 p.m. Uh there will be 14 runs each day from Clarksville at the River Falls Mall to Sellersburg and back. There will be approximately 16 stops in the Sellersburg area. Just turn it around the other way Dave, that will probably do it. There will be 16 stops in the Sellersburg area. The route will be basically from the Mall

across Progress Way, up 31 north to route 60, across 60 west to 311, and then northon 311,

all the way up into the middle of town, Utica and New Albany, come down Utica, go down to Fern make a loop around Fern and Popp and the come back out.

Mr. Welch stated will they have connecting buses to Louisville.

Council Member Fenner stated absolutaly, you're ahead of me. They, each of those runs will be a direct connection to the Second Street Louisville route. The Second Street Louisville route will take you to downtown Louisville. It will take you to Kentucky Kingdom, it will take you to the airport, all right, non-stop route not non-stop direct ok, you will have to transfer and change buses again. And also it will connect to the New Albany shuttle as well. There will be a delay if you want to get to Jeffersonville but it will be a direct connection to New Albany and a direct connection to second street in Louisville. I really think that is a great thing for Sellersburg. It will probably be a small mini bus. It won't be able to catch that. It will put them in access to a lot of area for a lot of different reasons.

Mr. Welch stated is this being done on a trail basis?

Council Member Fenner stated they haven't said it was a trail basis. They have not approched it as a trail basis. They said this is what we are doing.

Mrs. Hicks stated with the 16 stops how are you going to facilated parking?

Council Member Fenner stated there will be some of those stops that will be in areas where there will be some parking places. I think however probably for many people it's designed for people who can't drive anyway. And so they won't have a car to park.

Mrs. Hicks stated they have to get to the bus stop is what I am saying. They have to get to the bus stop generally speaking you would have a vechicle that is going to be parked.

President Eddings stated a lot of people are dropped off or walk to the bus stop.

Mrs. Hicks we're talking new routes in Sellersburg.

Council Member Fenner stated they won't come to your house to pick you up. It will be up to the people to get to the bus also. And however they choose to do that. I'd say with 16 stops and some of them being at say uh, what's the name of the, offical name of Jay C and the drug store is?

ORDINANCE NO. 1998-693

AN ORDINANCE OF THE TOWN OF SELLERSBURG, INDIANA, ADOPTING A NEW SCHEDULE OF RATES AND CHARGES FOR WATER SERVICE

WHEREAS, the Town of Sellersburg, Indiana owns and operates a municipal water utility (the "Utility") for the purpose of providing water utility service in and around said Town; and

WHEREAS, the Utility's existing rates and charges for water service were approved by the Town Board and placed into effect following the Indiana Utility Regulatory Commission's ("IURC") approval thereof in Cause No. 39064, Order dated October 9, 1991; and

WHEREAS, the Town of Sellersburg has employed H.J. Umbaugh & Associates to perform a study of the Utility's revenue requirements under IC 3-1.3-3-3, and

WHEREAS, the Town Board of the Town of Sellersburg now finds that (I) the Utility's existing rates and charges for water service should be increased, and (ii) the proposed rates and charged attached hereto as Exhibit A are designed to that they are nondiscriminatory. "reasonable and just charges" for services within the meaning of IC 8-1.5-3-8; and

WHEREAS, it is desirable to provide funds to compensate the Town of Sellersburg for taxes that would be due said Town on the Utility's property were it privately owned; and

WHEREAS, on January 12, 1998, the Town of Sellersburg filed a Petition with the T.T. Seeking approval of a new schedule of rates and charges, which Petition was docketed as Cause NO. 41107; and

NOW, THEREFORE, BE IT DRD and IED, by the Town Buard of the Till tof. Sellersburg, Indiana, as follows:

Section 1. That the rates and charges of the Sellersburg Municipal Water Utility be increased as proposed in Exhibit A, which is made a part hereof.

Section 2. That the above and foregoing described rates and charges provide compensation to the Town of Sellersburg for taxes that would be due the Town on the Utility's property were it privately owned.

Section 3. All ordinances and parts of ordinances in conflict herewith are hereby repealed effective at such time as the schedule or rates and charges herein set forth become effective.

Section 4. This ordinance shall be in full force and effect from and after its passage, provided that the schedule of rates and charges herein set out shall not become effective until it is approved by the IURC, or said rates and charges may otherwise be lawfully imposed.

WHEREAS, responsible planning and Indiana Law requires adoption of a fiscal plan and a definite policy for provision of services to annexed areas; and

WHEREAS, such plan has been developed and presented to the Yown Council for the Town of Sellersburg, Indiana, entitled "Analysis and Fiscal Plan Annexamen Area)" and

wHEREAS, said Fiscal Plan addresses the need and the implementation of aoncapital services to the annexed areas, including police protection, fire protection, street and road maintenance, and other noncapital services normally provided within the corporate boundaries, which will be provided to the annexed territory within one (1) year after the effective data of annexation, and that said noncapital services will be provided in a manner equivalent in standard and scope to corporate boundaries that have similar topography, patterns of land use, and population density; and

WHEREAS, said Fiscal Plan addresses the need and the implementation of capital services to the annexed area, including street construction, street lighting, sewer facilities, water facilities

and stormwater drainage facilities, which will be provided to the annexed territory within three (3) years after the effective date of the annexation, and that said capital services will be provided in the same manner as those services are provided to areas within the corporate boundaries that have similar topography, patterns of land use, and population density, and in a manner consistent with federal, state, and local laws, procedures, and planning criteria.

NOW, THEREFORE, BE IT RESOLVED by the Town Council for the Town of Sellersburg, Clark County, Indiana, that:

- That the Town Council for the Town of Sellersburg, Indiana, hereby approves the adopts the fiscal plan. "Analysis and Fiscal Plan Annexation Area I", which plan is attached hereto and made a part hereof, and hereby approves and adopts specific policies for implementation of the plan as set forth therein;
- 2. Any monies necessary for provision of services as described and itemized in the attached plan shall be budgeted and appropriated from the applicable funds, pursuant to Indiana Law and the Town's budget procedures;
- 3. It is anticipated that this annexation will not result in the elimination of jobs for employees of other governmental entities, but in the event that it does, the Town Council for the Town of Sellersburg, Indiana, and all of its departments are hereby directed to assist such employees in obtaining new employment, but nothing herein shall require the Town to hire any such employees.

PRESIDENT EDDINGS PRESENTS MINUTES OF LAST MEETING.

President Eddings stated Ok each board member's got a copy of the uh, minutes from our last board executive meeting and our regular board meeting. I'd like to entertain a motion to accept the minutes as presented.

Council Member Alexander stated I'll make a motion to accept the minutes as presented.

President Eddings stated motion made by Ken, do I have a second?

Council Member Fenner stated I'll second.

President Eddings stated second by Gary any discussion? If not, all those in favor signify by saying I, opposed nay. I's have it. Vote 3-0

President Eddings stated ok, petitions from the citizens tonight, is Greg Furnish here?

GREG FURNISH ADDRESSES THE COUNCIL ON/ALLENTOWN ROAD PROPERTIES.

Mr. Gurnish stated I'm Greg Furnish uh, what we are purposing is to get some discussion, some premiter discussion for myself and Paul Premiveria. We are discussing Allentown road property and some sewers into the Town Of Sellersburg.

Paul Premiveria stated Greg is uh purchasing some property on Allentown road just a little North of St. Joe Road, and he want's to develop this as a residental subdivision. Uh, we were talking with Mr. Toombs about the possibility of extending sewers, we've also talked with Covered Bridge as far as going with them to do what's necessary to bring the sewage from the next session of Covered Bridge along with his development to Sellersburg sewer system. The reason that we are talking to you this evening is so that uh, Greg has a bid to go ahead with the preliminary study, as far as the feasible of doing that, and in the manner that will be suitable to the town, the town's engineers. But, before doing so, he feel's like he would like to get some sort of indiciation from the town if it is feasible. If the town would be willing to accept the sewage from this project.

SELLERSBURG TOWN COUNCIL Regular Meeting June 22, 1998 Page 2.

GREG FURNISH ADDRESSES THE COUNCIL ON/ALLENTOWN ROAD PROPERTIES.

Right now he is probably around 130-150 lots on his present project. Covered Bridge is real close to starting their next stage and they will have somewhere between 100 to 150 lots in this phase. So, it's an opportunity for these parties to go together to implement the uh, consturction necessary to handle the sewage and uh, at this point we would like to initally get some indication from the Town Board uh, to do things that are acceptable, if they would commit to the sewage treatment of this project.

Council Member Alexander stated my first question is will this new sewer system uh, take care of any or I mean any of the residents that are existing along Allentown Road to Covered Bridge?

Mr. Premiveria stated at this stage, what we are planning on doing is the existing lift station on Allentown Road just before St. Joe road is where the discharge plant, the Covered Bridge sewage and the additional sewage from this project and there is going to need to be a new pumping station to deliver the sewage all the way over to the Lift Station at the high school. The answer to your question would be a gravity inlet there for sewers on the north side of the road, yes.

Council Member Alexander stated I quess my question is if someone halfway up uh, Perry Crossing, or Allentown want's to hook on the sewer they would be allowed?

Mr. Premiveria stated well, the existing force line uh, Covered Bridge with the uh, with the addition of the second phase will basically be operating at capacity. Mr. Furnish's project will probably also. At this point will probably have to have a force, a Lift Station on his side. However, it will open the opportunity for others to tie into this Lift Station with gravity extended north but to tap on to the force line uh, Covered Bridge would not be feasible. Possibily uh, Furnish's might be able to be tapped on somewhere. Right now your Lift Station at just north of St. Joe road is from my understanding at capacity this would elimate, make it available for a lot more sewer's to picked up at this point. It would be up to other developers to get the sewage to the Lift Station.

Vice-President Broady stated is this going to also increase are we talking about an increase in the line underneath 65 to pick up uh, have we discussed that? I mean have you discussed that with him Paul?

Mr. Toombs stated well we have talked back and forth about how to go about it. But basically this is, it takes sewage. It is sewage, where the existing Lift Station is by some route to the high school. Eigher wiggle your way over to 31 along the creek or make a new route or something like that.

Vice-President Broady stated has our capacity on the first link to the high school to the treatment plant are we well...

Mr. Toombs stated we have a pretty good size line from that.

Vice-President Broady stated we do have, we can get it to the Lift Station there at the high school, we probably have, I think you said possibly uh, up upgrade that Lift Station with bigger pumps. We don't know yet.

GREG FURNISH ADDRESSES THE COUNCIL ON/ALLENTOWN ROAD PROPERTIES.

Mr. Toombs stated it's possible that we need a pump or two-in there but we don't know that yet. It's just a matter of how much. And we can't just guess we have to find out how much somebody own's that we're talking about. How much capacity that we've got, if any.

Vice-President Broady stated what Kenny was talking about I think the answer to that was then if I understand what you are saying that persay they won't be any gravity going into this phase of the project going up Allentown road. You will operate off this station to capacity on your Lift Station could be upgraded to the fact that we wanted to run gravities up Allentown we could tie in the Lift Station or whatever is that what I'm hearing.

Council Member Fenner stated yes, all gravities you're talking about will be gravities for the new homes that you're going to be consturcting has Covered Bridge?

Mr. Premiveria stated yes, any existing force main that comes from is all the way down to the existing Lift Station. If they go with phase two, Covered Bridge the capacity will be used up. Houses that live along there now will not have an opportunity to connect anything new, they won't be anything new going out that way.

Council Member Alexander stated well what about just the existing? I mean I know if the town would ever want to take the option to annex as far as Covered Bridge I mean by not having this line to where it would at least take the existing home on Allentown road the annexiation would be almost impossible.

Mr. Toombs stated that's why you extend it to the existing too.

Council Member Alexander stated right, I mean you're talking about almost what I mean most of them won't hook up to it. Just the existing homes there, is no way to take into calculation the existing homes going up Allentown road.

Mr. Toombs stated not on the existing pipe. The existing pipe was designed along time ago for Covered Bridge.

Mr. Premiveria stated but it does give you the option now to run gravity to a point, north on St. Joe road which you don't have at this point. So out of respect it does open that area up for the system to reach the new pumping station which would go along with this type of project.

Vice-President Broady stated we're getting the capacity I think underneath 65.

Council Member Fenner stated did he ever answer your question about the capacity of going under 65?

Vice-President Broady stated he did, I assume that's what I heard.

Mr. Toombs stated we've had this discussion many time's before way back when it first came to the town, anything more than the phase one of Covered Bridge came in out there somebody had to do something. We've never been able to get group of people together.

Mr. Fenner stated we want to make sure whatever we do, as Kenny said we don't mess ourselves up in the future, as far as possibly doing annexation out to Covered Bridge.

GREG FURNISH ADDRESSES THE COUNCIL ON/ALLENTOWN ROAD PROPERTIES.

Council Member Alexander stated what I am hearing tonight is annexation is probably going to cost 500,000 for our own.

Vice-President Broady stated it would be X number of dollars to run your own gravity if that's what you wanted to do, but however you wouldn't be building a Lift Station or adding a larger capacity under 65. That would be there and be able to handle what we wanted to do.

Council Member Fenner stated that would already be there.

Mr. Toombs stated as you will remember when we gave Covered Bridge permission they had to agree to not only they themselves but the people they sell to someday could not object to annexation.

President Eddings stated that will be included in this also.

Mr. Toombs stated and approval to do something like this is always one of the conditions.

Council Member Alexander stated but you can't skip the blank spots. You could never annex point B. So I mean I don't see where there would be you know everybody talks about they're agreeing to come into town but that's along way out there as far as Sellersburg having monatery capability of putting a gravity sewer in there just to make that happen you know. All I'm saying is there's only about what 30 or 40 houses out that way that run along. We only have to take care of the existing homes, not anything new.

Mr. Toombs stated we don't have any obigation to do anything.

Council Member Alexander stated if we annex we do...

Mr. Toombs stated I wouldn't advise you to. Where is this thing we're talking about? Is it ajacent to the town now?

Mr. Premiveria stated go north on Allentown road. It's, take a quick left then a quick right and it's on the left.

Council Member Fenner stated about a mile out there past the Lift Station.

Council Member Alexander stated I'm not talking about the second phase of Covered Bridge. I'm just saying is there not any, we're just changing the I-65 and were using the existing line.

Mr. Premiveria stated I think the advantage to the town is that right now we want to add somemore homes at gravity north of St. Joe road you cannot get to your treatment plant because you are at capacity now. Once this, if this project went through, you approved it and made feasible there would be extra capacity built in the Lift Station so now if you wanted to add gravity you would be able to get the sewer to your treatment plant.

Council Member Fenner stated there will be that extra capacity, that is what you are saying.

GREG FURNISH ADDRESSES THE COUNCIL ON/ALLENTOWN ROAD PROPERTIES.

Mr. Premiveria stated yes, we plan to work with Mr. Toombs and work up the numbers that he recommends that would not only work with this project, but with other projects as well. Once we get the force line it's not real expensive.

President Eddings stated the only thing that I ask is doesn't Wilson have some project working out there as well? You have Rick Wilson and other developers as well just make sure everybodies communicating and working with each other when they put these systems in. We don't want to have to settle any disputes amoung them later on. That happens alot, when we're sitting up here.

Council Member Alexander stated I just want to clarify it for myself one more time. If we want to go to Covered Bridge there will be capacity all the way down to the St. Joe Lift Station which is next to the creek, correct.

Mr. Premiveria stated yes sir.

Council Member Alexander stated the St. Joe road Lift Station is the one down there by the creek. Ok, if we want to go North ok our only option is going to be running another gravity line to covered, I mean basically if we want to go to Covered Bridge we got to serve all the houses in between and go to Covered...

Mr. Toombs stated you can go to covered Bridge if you wanted to or to certain areas.

Council Member Alexander stated we can't take out the old line and resize it.

Mr. Toombs stated no, Covered Bridge was originally planned more that one phase.

Council Member Alexander stated right.

Mr. Toombs stated so the design of the Lift Stations that are out there will accommodate those phases and also design the force main that starts way out there to Covered Bridge goes all the way down to our Lift Station for all of Covered Bridge, but not for any of the houses in between not even for Rick Wilson's. What they are proposing now is something dramatic for St. Joe road, so once it gets to that point then the high school. The expensive part is getting from there to the high school. Not to the Lift Station. The Lift Station is a lot less, it doesn't cost as dramatic dollar. Capacity will be added at that point, Any future development. You could extend uh, a gravity sewer up to a certain distance up hills in all four directions and then you run into limitation of the gravity.

Council Member Alexander stated so we need more Lift Stations and more lines. Ok, I think I've got you. It has nothing to do with the existing line that is there.

Mr. Toombs stated it is something we have talked about when Covered Bridge came around. Once they got things to they were going to have find a different way to get things around.

Council Member Fenner stated as far as we're, I mean as long as we're thinking 20 years down the road, where we are and what we might do, what would be best for the town 20 years from now, I think that's the key.

President Eddings stated ok Thank You.

Mr. Premiveria stated Thank You.

Mr. Furnish stated Floyd Riggle property, you probably know that name. That's the property I purchased.

President Eddings stated ok Mr. Bolly.

VIRGIL BOLLY ADDRESSES THE COUNCIL ON/RITE AID.

Mr. Bolly stated I'm Virgil Bolly and I'm here tonight on your request on the rezoning of the property over on 60 and 311 uh the Wells and the Johnson property and adjoining the Wells property uh, the board of Zoning Plan Commission, has approved I think coupla weeks ago for I think to appove this after quite a bit of time studing the input, the roadway and things of this nature I think that board felt like the, that uh it was something that the highway department should address and they approved it four to nothing which brought is up here to you all. Uh my question is to you do you want additional testimony, want anything else at this point?

Council Member Alexander stated the only thing I have is, is there any way for the state to approve or disapprove the uh, entry way ahead of time?

Mr. Bolly stated for the zoning to be B-3 uh, the Johnson property which uh, adjoins the Wells property which is already zoned B-3.

President Eddings stated in the Planning Commission meeting they voted to go ahead and rezone or change the zoning to a B-3. And it only makes sense to coz the sections of property around there is B-3. Uh, the plans that were brought to us, showed that there was additional cut outs on limited access to highway 60. Some of us on the Zoning Board had a problem with the additional cut out. We didn't like them. Uh, there's meetings going on with the Department of Transportation, but they are the governing body for those cut outs for the access on highway 60. Not the Sellersburg Town Board. We felt it was alright to go ahead and change or recommend to go ahead and change the zoing to B-3 and then leave the jurisdiction up to the Department of Transportation for the State of Indiana. Personally I still have a problem with additional cut outs on highway 60. The last time that they put cut outs on 60 was back when they put the Hunter Station and Hertiage Square cut outs in on 60. And we got a letter here from the Indaina Department of highways that stated in 1988 when the Hertage Square property went in and this three things that the State Highway Department wants. And the very first one said the developer must work with and get the agreement of the property owner on the opposite side of S.R. 60 for the development of one "intersection" which would potentially serve both properties. This intersection is to be situated for optimum traffic flow on S.R. 60 irregardless of impact on proposed development plans. The Indiana Department of Highways has the sole right to determine if any proposed location is acceptable. This proposal is to have the written support of the local board (Planning/Zoning) which have jurisdiction must commit not to support any future request to cross the limited access right-of-way of S.R. 60. So what I'm saying is basically we support the changing of the zoning, residental to B-3, but as far as my position and I would, may make it in a form of a motion uh, to see if we can get the rest of the Board either to submit, support or not support. I do not support any additional cut outs on Highway 60 less than a thousand yards from the traffic light.

Mr. Bolly stated I understand where you're coming from. And again I would request the zoning but let the State work out the details.

TONY NOLAN ADDRESSES THE COUNCIL ON/SHUT DOWN OF PARKING ON FERN ST./SPEEDERS.

Mr. Nolan stated my name is Tony Nolan, I live on North Fern St. and I wanted to uh, bring your attention to and discuss the traffic on North Fern. First of all let's just say this is in no way a complaint about the Park itself. We all like the park, and it's been a service to uh, the community, however we see a tremendous amount of traffic on North Fern, especially with the activities going on at the park. Some of the things we see is just the regular car traffic, pesterdain, people on the roadway, bicycles, uh trucks, the semis going to the business and motercycles and anything else that transports people up and down this road. Uh, it's basically safety that I'm concerned with. I have several children and there's really no way to keep the uh, the speeders to slow to a reasonable pace. Uh, I don't know any real solution, I don't have any specific solutions other that uh, there seem to be only one access to the park. And that's North Fern. You can go up Adkins take a left on Adkins and go in on another route. You can take a little alley right next to the Carpet Barn and that's not safe because it's extremely narrow and that takes you into the park. Uh, there is another access but that's not really, I wouldn't say it's really for that purpose and that's to go through business, using service drive. Some people have started doing that and they don't like that but it is open. It seems to me like it needs another access to that park. We need to at least to have some signs up saying slow down, children playing or whatever. There's nothing there now except one 20 mile an hour speed limit sign. Uh, solutions you could open it up to Helbig, there's an access road that goes around the track, and an enterance to 403 that's probably not feasible. You could cut into the American Legion, that area, that's close. It looks to me like there's probably several solutions to it. Uh, I'm not in a position to dictate as what to do other than to. North Fern is becoming a hazard. Maybe a sidewalk for the pedestrian, kids riding bicycles or whatever, mothers with strollers or whatever. I called the police several times and they have responded and uh, juradicition seems to be a problem. The park is in the county and all the access roads are in the city. So there's a little bit of run around on who to call. Well that's not us that's in the county, no the county, it's in the city. So some clairfication need to take place there. Uh, I would just try to uh, I just really need to bring it to your attention, so some solution could take place. Maybe, I don't know if we close off North Fern and go in through the access road or what. But uh, that's a problem that's not going to go away until somebody addresses it. And it would be better to do it before somebody gets hurt. Uh, this came to a head the other day when they closed off parking on Fern. I'm fortunate my property has a lot of parking areas, we do park on the street, but we don't have to. Parking on the street does slow on the traffic some. It's the only thing that does slow the traffic some. Coz everybody has to stop for a one lane approach, that slows everyone down. So that was a uh, only contention when they took the parking off. Actually the Rod Run or whatever they had the other day there was really no traffic on the end for some reason. Everybody used the access road. So it didn't really become a problem that day.

Council Member Alexander stated used which access road?

Mr. Nolan stated I guess they used Adkins Court.

Council Member Alexander stated they used Adkins Court, but they actually allowed the parking on the road coz most of them didn't, there wasn't a lot of high traffic cars as far as speeding and so forth. It went smoother because you didn't have the back up because of the one lane road. I mean I agree with you on the one thing, it does slow them down, but it does present a problem when you have alot of traffic both ways as far as backing up.

Mr. Nolan stated that is exactly the plus.

Council Member Alexander stated yes, it slows people down.

Mr. Nolan stated that's a problem I like. Well, that's it basically.

Vice-President Broady stated we still getting truck traffic on there? Why.

Mr. Nolan stated semi's go up, there is a sign for that, telling them to use the access road. I think the truckers that know about it go down and use the access road. We probably get two a day.

Council Member 'Alexander stated two a day.

Mr. Nolan stated yea, two or three a day.

President Eddings stated same two.

Council Member Alexander stated probably, I mean they come down Adkins Court too. I mean it's nothing for six o'clock in the morning to hear a big semi come through or trying to back out of Adkins Court coz he went the wrong way.

Mr. Nolan stated my neighbor had an enterance torn out last year because of a big truck. I'm not as concerned about that as I am the speed. But there is a concern. There is an access road, I think the agreement was before I moved there they would use the access road rather than use the uh, North Fern Road. I don't have any purposals or anything like this for you. I would like to be enlightened to what could be done there.

Council Member Alexander stated the possibility would be looking at another enterance. Theree's always been talk about it, uh if things grow there, you know I, what I look for is there's going to be a need for another enterance. No one disagrees with what you are saying. There are some people there right across the railroad tracks that have no parking in their yard at all.

Mr. Nolan stated that's right.

Council Member Alexander stated there's really no way to widen Fern Street. Uh, coz of the houses on the south side of the track. The only options are basically what you listed, Service Drive, Helbig, over by the American Legion, or through the church area, Uh although there is an area that would be a lengthy road.

President Eddings stated do we have any slow children playing signs that we could put up?

Council Member Alexander stated we could put slow, but what, really we haven't seen I mean a lot of the time is children ramping the uh, railroad at 10:30 at night. I mean I can sit out on my back porch on a Friday night and we can watch the mufflers off the bottom of the road. Durning baseball season and football season and so forth uh, there are parents that are late that go faster then they should there. But I don't think a sign will make the difference. I know we could maybe put something else...

Mr. Nolan stated the only thing that slows them down right now is the fact that people park on the road. They have to stop for a one lane road for passing, just enough to get by. That dows slow them down. But...

Council Member Fenner stated has the Town Council ever had discussions with the trustees of the park to address this problem?

Council Member Alexander stated I don't.

Council Member Fenner stated I know it has been before the Town Council many times, have we actually sit down with the park people and said ok lets lay something out, let's work together and try to correct the problem. Is that something maybe we need to do.

Council Member Alexander stated I think it would be a good start.

Council Member Fenner stated if we need to we could drag in businesses over there.

President Eddings stated that would be a good place to start.

Ms. Beasil stated I'm Kim Beasil and I live at 620 Nevada Drive and I'd like to show you some pictures of the flooding I've had in the past and still have in the future. I'd like to see what you guys could do for us and like to say I think as long as you don't do anything to the property I won't be able to sell my property because I'm afraid if I was to move and sell the house to someone else, they would have the flooding problem that I have I could be sued for this and I think something needs to be done. Mr. Alexander has lived across the street and he knows about the flooding. The gentleman at the end has been out to my house and heard and seen about the problems we've had. And I'd like to show you my pictures and see what you could do.

Vice-President Broady stated are you familiar with this area here.

Council Member Alexander stated yea, it's plenty, it's just, what did we guess John? Four to five. I mean it's just something we don't have in a year's budget and because they're at the back of the line instead of the front of the line. I mean we did put some kind of purposal together maybe to do sections from one end all the way up. But we wanted to wait to see, it's the two pipes that run through uh, Hill-N-Dale that go from Nevada over.

Ms. Beasil stated we have, uh, storm drains or easements that when they get sofull they come to the top and they flood yards. We have a concrete pipe that comes out three doors down from our house that water floods into and comes from Sharps. When everything comes down the easement it all comes in my yard. I have all kinds of debris I have to go out and clean up you know like I said I can't sell my house knowing that this is happening. An I supposed to be forced to live there? You know and deal with the flooding and not be able

Ms. Beasil stated what you have done my flooding goes to Lane when my yard floods it goes across the street. You can see the pictures there is actually a picture in there of the easement of Nevada and Lane where all the water goes to. What you all have done over there has nothing to do with my problem.

Council Member Fenner you're above that. And your's is coming, alot of your's is coming from Sharps.

Council Member Alexander stated yes.

Ms. Beasil stated it's coming down the easement from Sharps Lane and all that Debris and the flooding that's in my yard. I can't even landscape. I mean coz it's all going to be washed away. I've had landscaping timbers in the front yard be washed away because of all the flooding coming.

Council Member Fenner stated has it always down that since you have lived there?

Ms. Beasil stated yes.

Council Member Fenner stated how long have you lived there?

Ms. Beasil stated uh, I moved there in October of 89.

Council Member Fenner stated 89.

Ms. Beasil stated yes, and I have been in here with these pictures before and I'm here again and I would like to be able to move. You know, not 20 years from now you know and I can't sell because I don't want to be sued. When it rains, water will sit there for three or four days, mosquito's. You know the neighbors have seen snakes over there. You know I have holes in the ground on my easement. They have come out and put concrete and still grows and I keep grass trimming in there. Next to the storm drains the concrete around the strom drains is washing away because it's gotten worse and I need to take pictures of that and bring them in and let you worse and I need to take pictures of that and bring them in and let you take care of that problem too. It's just getting worse and worse back there. I mean you can come back there and a day and it might and you saw what I had to deal with. I'd like to know what could be done about this.

Vice-President Broady stated you got any idea of estimated cost of I mean of...

Mr. Toombs stated not right off hand. Ken and I have been out there and looked at it.

Council Member Alexander stated well like I said it's going to exceed the one-year budget. I mean the only way to solve this one is would be...

Ms. Beasil stated Sellersburg buy my house so I can move.

Council Member Alexander stated a short term loan.

Council Member Fenner stated you're not moving out of town are you?

Ms. Beasil stated no, I didn't say that. I just want to move out of that house if I'm going to continue to have a flood problem. No one's going to want to by my house and they get flooded.

Council Member Alexander stated we talked about two months ago that there were certain problems in Sellersburg that we were not going to be able to fix on a normal budget year. Uh, we have put them all together in order to get a short term like four or five years to work on it.Or find some feasible way to start to at one end and work your way up. Haven't forgot about you, it's just...

Ms. Beasil stated we fixed our basement up a year ago on Christmas ok. Three months later our basement flooded. The carpet got wet, all the drywall got wet. I can't put new furniture down in my basement. I can't do nothing else to it.

Council Member stated yes.

Ms. Beasil stated I mean how would you feel if you had a house that you could not sell because you were afraid of being sued by someone else because of a flooding problem? I mean I would like to move I really would, I don't want to get sued.

Vice-President Broady stated is this a three hundred thousand-dollars project or ...

Mr. Toombs stated this is a big, big project.

Council Member Fenner stated where does it rank on the priorty scale? I mean is it the worst...

Mr. Toombs stated we don't have the three hundred thousand, there is no priorty. We don't have the money.

Ms. Beasil stated well can you hold off on other projects and solve my problems so I can at least move someday? I mean...

Council Member Alexander stated it's not something that easy.

Council Member Fenner stated it's the budgeting process. And you can't carry money over from one year to the next and so in this fund we a certain amount of money each year, that money has to be spent in the year and you can't save it for the next year. Copies of all the invoices are attached to the packet along with the original invoice.

President Eddings stated I'll entertain a motion to reimburse EMC for the water service for the New Nursing Home on highway 60.

Mr. Coleman stated that is money that has been collected.

Vice-President Broady stated I make a motion to do so.

President Eddings stated motion made by Dave, do I have a second?

Council Member Alexander stated I'll second it.

President Eddings stated second by Ken, any discussion? If not all those in favor signify by saying I, opposed nay. I's have it. Vote 3-0

Mr. Coleman stated a coupla of things that you don't have in front of you I need to bring to the board's attention, we have two sewer lines, one on Edgewood and one on Foothill. Uh, I gave a rough drawing to John the one on Edgewood these lines are deteriorated beyond repair and uh, the guys now are continually going out there. We had complaints on them for several years now, uh, the one on Edgewood is deteriorated. It's an old pipe and it's paper-thin, we're repairing it three times a year. We're getting several customer complaints out of that area. And I'd like the board to recommed on how to proceed on that. The estimate for replacement on Edgewood will be around \$35,000.00. That is engineering estimates. We received on bid from a contractor and it was a little over \$35,000.00. That is replacing 750 liner feet and three manholes. Uh, the one on Foothill I don't think is going to be quite that expensive. We're looking at 670 liner foot. It's only about three foot deep, we won't be able to put the manholes in coz it's so shallow. It will save a little bit of cost on manholes, but we are getting several complaints from the customers on the service line. We need to look at replacing both those lines.

President Eddings stated which one's worse?

Mr. Coleman stated toss of the coin, toss of the coin. You've got taproots in both lines. Taproots get in the laterals and the service to the homes and going down into the main lines. Once they're there you can't get them out. Not unless you cut all the trees down.

I would say let's go ahead and do it, let's get bids on that 35,000, and no let's get bids on both those projects. Can we break them down seperatly so it won't be such a shock?

LateFebruary, early March uh, we started having tests with new primeters starting in April and we cannot comply with one of those primeters. It's chlorine resudial. Either the chlorination of the water before we sent it to the distribuation center, we back wash our filters with that water. That goes into the laggons, we got chlorine residual left. We have a level of point 05 milgrams per liter. Right now we're reporting one to one and half milgrams per liter. Also with that our TSS limits are hovering right at our primeters limit. Uh, TSS that was one of the reasons why we recommended a Capitol Improvement for cleaning our Lagoons. We're getting the solids to settle up properly, they're going through the lagoons too fast before getting discharded. So right now just to make the board aware, I mean you're looking at probably what we'll have to do is install a sulfur dioxide system before we can discharge in the ditch.

Council Member Alexander stated what if we went sewer down?

Mr. Coleman stated it's going to be expensive. I mean you're looking at we back wash three days a week, about 25,000 gallons of backwash, about 75,000 gollons a week in discharge in sewer. Two hundred fifty to 300,000 gallons.

Vice-President Broady stated it wouldn't matter.

Mr. Coleman stated we're going to look at options, I mean it's, I think it's going to be costly. And you continue to develop here, the more water we're processing, the more water we're producing, the more we're going to be back washing and the more will be discharged into that sewer system.

President Eddings stated would the uh, system be needed even after the uh, retenttion ponds are clean?

Mr. Coleman stated that something I'm going to bring our experts from our Evansville Facilities. They have a lot more knowledge than I do Doug and I want to get their recommendation and talk to John as well and see if they think that would correct the problem. The residual is so high, I don't think that's going to correct the problem.

Uh, I have here your analysis of you're Fiscal Plan and Annexation of area I. I turn to the second page. It say's these services with Capitol Improvement Nature including street construction, street lighting, sewer facility, water facility, storm water drain facilities will be provided for the annexed territory within three years. Is that right?

Vice-President Broady stated yes, I would say so.

Mr. Very stated prior to that it says the planed sewer is a Non-Capitol Services normally provided within the corporate boundaries will be provided to the annexed territory within one year of the effective date of annexation and they will be provided in a manner in an equivalent standard and scope of those uncapitol services provided in area within the corporate boundaries that have similar type of patterns they use and population and density. All right, you make a comparison against Wood-Haven area on St. Joe Road east of I-65 North and West of Dreyer Lane. I assume that is already in the Town Of Sellersburg. Is that right?

Vice-President Broady stated yes I think so.

Mr. Very stated ok, the Fire Protection will be the same as we have now. On the County Line Road. My half of the road which is Clark County. There will be no change in that.

Vice-President Broady stated correct whatever is in there.

Mr. Very stated Garbage Collection, the Town Of Sellersburg provides one garbage pick-up per week for residents businesses and industries. There will be a three-dollar's a month charge. For the first pick-up and an additional charges providing of dumpster type containers. The annex of area I will not effect an additional personal equipment. And that is because you are using BFI are you not? Or do you have your own?

Vice-President Broady we have our own.

Mr. Very stated all right, it will be an expense the sewer this is under sanationary services to serve the existing residents of the area not now on sanitary services. Now, I'll go back to that later. Over here on page eight under streets. Fire Protection we have the same thing as we have now because the Volunteer Fire Department covers the Township. The Clark County roads are located within the area I for which town will assume maintain responsibility. Now I have a question. The law says when two counties come together on the line halfway between the two ends of the road the each uh member of each group faces it and the one on the right goes to the in this case to Clark County and the one on the left goes to Floyd County and this on the County Line Road which runs approximately to the church on St. Joe goes to the corner pole. And so the half is being taken care of Floyd County goes right down by your annexation. Who's going to take care of this road? Clark County, Floyd County, or the Town Of Sellersburg?

Vice-President Broady stated do we have any of that annexation on County Line Road John?

Mr. Very stated this right here you have a map here it is in the back of the annexation area. We're talking about, my question on sewer's and I got a blow up here of all the annexed areas. This come's from uh the geologically map in New Albany-Floyd County Library and this is a blow up of it. And what you've got, all right you're going to take in this section in right through here which is the whole section here and two things I want to comment about. This is my property here and this is a small piece of ground there. This top of getting near of the crest of a hill. I don't know how far you're sewer goes out. Can anyone tell me?

Council Member Alexander stated to the top of the hill, that's Virginia Heights subdivision.

It say's all and I think that you mean all, is that right?

Vice-President Broady stated yea, I mean what we're trying to do was put in a Lift Station.

Mr. Very stated all right but I mean are you going to service, I got one house on my property are you going to service that house?

Vice-President Broady stated we've got what three years to do so. Yes sir you have to, that's in your ordinance here. You have three years.

Mr. Very stated three years.

Vice-President Broady stated three years.

Mr. Very stated you're going to put the one down there at the bottom of the...

Uh, if they want to be part of the government that seems to be closest to their community that they live in.

Resident stated well speaking for Mr. Very here, I don't live in that area but I'm his son-in-law, I just looks to me like uh, the services offered are probably not gonna to be as great as the some of the taxes purposed.

Vice-President Broady stated I understand.

Resident stated for some time and I think that's why there's a certain reluctance for people to jump right in and say that's great.

Vice-President Broady stated and I agree with that. As Mrs. Elder said she said some-body's going to get you sooner or later.

Resident stated I think people would rather be in Sellersburg than Clarksville.

Vice-President Broady stated I think so too. It seems like they're closer related to Sellersburg than Clarksville.

Resident stated but I think want to wait for the population density to increase that way the services will be more immediate and uh more in depth.

Vice-President Broady and another thing I talked to the people that maybe had of looked us, is that the government here controls the sewer and a lot of things we do as a government here doesn't necessarily, I mean we don't put a stop sign up on his street, but things that we do make the decisions as far as the annexation, not annexation but

Rigth now Hunter Station is estimating all the way through back to Clarksville is estimating 40 million dollars of tax base that could have been Sellersburg. But we chose to sit and wait and see and uh, and if Clarksville came in March of 2000, Sellersburg doesn't get to say oh by the way we would like it. I mean we either have to be first or they're first. Uh, even though I lived over there I would not want to pay the higher taxes I would hope that because of the close knit community that we are the people would understand. This would draw a line in the sand where Clarksville would be persia boxed in unless they could go into Floyd County and go around and the threat of other properties that Sellersburg could develop would be reduced to where we can develop as a community in the pace we want instead of the pace of the neighboring community. Because we have no say in what goes in there or what doesn't go into Hunter Station even though you could pick a stone up ; and throw it across the street. And you know having at least a public opinion this is what we want to build or what we don't want to build or how fast we want to grow or how slow we want to grow. I don't know if that's worth the dollar or not but at least that's a positive look as far as uh, a local government being close to home.

Resident stated I'd like to make one more comment. In the recent event that happened on Poindexter I think the extra Police Protection would be a plus for us. I'm sure you know what I'm speaking of.

RESOLUTION OF THE TOWN OF SELLERSBURG, INDIANA APPROVING THE TRANSFER OF THE CABLE TELEVISION FRANCHISE

WHEREAS, Insight Communications Company, L.P. ("Franchisee") owns, operates, and maintains a cable television system ("System") in the City of Sellersburg, Indiana (the "Franchise Authority"), pursuant to a contract dated May 24, 1966, a Cable TV Franchise Amendment dated March 13, 1979, Ordinance No. 425 dated April 28, 1986, and Consent to Assignment dated May 12, 1986 (the "Franchise"), and Franchisee is the duly authorized holder of the Franchise; and

WHEREAS, Franchisee, TCI of Indiana Holdings, LLC ("TCI"), and Insight Communications of Indiana, LLC ("Transferee"), together with certain other related parties, are parties to an Asset Contribution Agreement and an Operating Agreement, pursuant to which the System and the Franchise will be transferred to Transferee (the "Transfer"); and

WHEREAS, Franchisee and Transferee have requested consent by the Franchise Authority to the Transfer in accordance with the requirements of the Franchise and have filed an FCC Form 394 with the Franchise Authority, and

WHEREAS, the Franchise Authority has investigated the qualifications of Transferee and finds it to be a suitable transferee;

NOW THEREFORE BE IT RESOLVED BY THE FRANCHISE AUTHORITY AS FOLLOWS:

SECTION 1. The Franchise Authority hereby consents to the Transfer, all in accordance with the terms of the Franchise.

SECTION 2. The Franchise Authority confirms that (a) the Franchise was properly granted or transferred to Franchisee, (b) the Franchise is currently in full force and effect and will expire on May 23, 2006, subject to options in the Franchise, if any, to extend such term, (c) the Franchise supersedes all other agreements between the parties, (d) the Franchise represents the entire understanding of the parties and Franchisee has no obligations to the Franchise Authority other than those specifically stated in the Franchise, and (e) Franchisee is materially in compliance with the provisions of the Franchise and there exists no fact or circumstance known to the Franchise Authority which constitutes or which, with the passage of time or the giving of notice or both, would constitute a material default or breach under the Franchise or would allow the Franchise Authority to cancel or terminate the rights thereunder.

SECTION 3. Transferee may transfer the Franchise or control related thereto to any entity controlling, controlled by, or under common control with Transferee.

SECTION 4. The Franchise Authority hereby consents to and approves the assignment. mortgage, pledge, or other encumbrance, if any, of the Franchise, the System, or assets relating thereto, as collateral for a loan. SECTION 5. This resolution shall be deemed effective upon the closing of the Transfer (the "Closing Date"). SECTION 6. The Franchise Authority releases Franchisee, effective upon the Closing Date, from all obligations and liabilities under the Franchise that accrue on and after the Closing Date; provided that Transferee shall be responsible for any obligations and liabilities under the Franchise that accrue on and after the Closing Date. SECTION 7. This Resolution shall have the force of a continuing agreement with Franchisee and Transferee, and Franchise Authority shall not amend or otherwise alter this Resolution without the consent of Franchisee and Transferee.
