Regular Meeting of the Sellersburg Town Coucnil was held at the Sellersburg Town Hall at 6:30 p.m. Those present were Dave Broady, Council President; Doug Eddings, Council Vice-President; Gary Fenner, Council Member; Kenneth Alexander, Council Member; William Voyles, Council Member; Linda G. Schafer, Clerk Treasurer; and William P. McCall, Town Attorney.

#### Called To Order

President Broady called the Regular Meeting to order at 6:31 p.m.

#### Prayer

Rev. Frank Brand

#### Pledge

The Pledge of Allegiance to the flag was recited.

#### PRESIDENT BROADY ADDRESSES THE COUNCIL MEMBERS ON THE MINUTES OF THE LAST MEETING.

President Broady stated we've got a copy of the minutes of the June 18th meeting in our box, and had a chance to read them. If so, I'll entertain a motion to approve the minutes as presented.

Council Member Fenner stated I make the motion that we approve the minutes.

President Broady stated I've got a motion on the floor do I have a second?

Council Member Voyles stated I'll second.

President Broady stated and duly seconded, any discussion? If not all those in favor signify by saying I, opposed nay. I's have it. Vote 5-0
The first thing on the adgenda tonight is the St. Paul will address the council concerning the closing of St. Paul Street.

Francis Connov stated Thank You Dave and the Town Board, there is a copy of the petition as well as copies of the petition. I know you already had it but this is another one. I'm here on behalf of St. Paul and St. Joe Hill Parish's and our shcool. On our petition to request that the town to close the section of St. Paul Street to Highway 31 to the intersection of Sellers Ave. There is 31 out here, St. Paul's Street, we're going to close back to Schellers Ave, it splits our property right now with the existing school on the south side and the new facility over on the north side of St. Paul Street. Our reason for doing that is for the safety and protection of our students. There will be alot of activities, crossing back and forth between the two facilites. St. Paul Parish and school has been a part of the community of Sellersburg for 50 years. We are celebrating our 50th anniversary this fall. The school K-6th and the same as Sellersburg, we have been experiencing a lot of growth in the last 6 to 8 years. The schools enrollment in 1990-1991 was 108 students, and this coming year 99-2000 we have 282 students registered. The original school had the capicity of about 220 students and in order to meet the needs of the two Parish's families wanting to attend the school, we're wanting to expand the school. This was done in conjunction with St. Joe Hill Parish joined together with us to

expand the school. The new facility consists of a gymnasium and 5 classrooms with the capacity of 150 students. Due to the fact that part of the students are Kindergarten through 2nd grade will be in the new facility. Third through 6th will be in the old facility. There are part of the classroom presenations will be in both schools as well as the gymnasium and then for the services that they have, sometimes in the church. Our only reason is looking after the safety of the students as they are crossing the streets between the two facilities and our real concern is the fact the fact that we are so close to the Highway 31 here, and the volume of traffic on there, that when somebody turns on, especially if they are going North on 31, on to St. Paul, in order to make sure that they cross, once they make that turn it's too late for the students that are crossing the street. Because it's only about 50 or 60 feet from the corner back up to the doorways between the two buildings. We believe with an alternate routes are available if this section of the street is this section is closed off for the people involved in the neighborhood. The one step that we have taken to address the issue, as we have told the town board before, we would grant an easement along St. Paul Street, Oak Street and Hauss St. you could widen those streets in those areas. And part of it has already been done in those areas, and the town has indicated they will be doing the rest of it later on. So we believe that the people will have the option of coming down this way going out Schellers down to Utica Street. They can come on Sellers to Utica, down to the highway or they can go this way, Oak Street and Hauss Street out to 31. The one thing that we would ask is it be done by the town is that the entire area around this lot of ours is the street would be designated No Parking along the street, because if we widen the street, the street still, from the time you take off, if someone is parked they can make passing very bad. So, therefore we do feel that it would be important that, that would be designated "No Parking" along that street. The one issue that was brought up last year was the congestion created along Sellers in the afternoon when the parents pick up the students up and so we instituted a policy last fall that the parents came inside. We close our playground to the students at dismissal time and the parents park inside there and not out on the street. You don't get 100% cooperation but I think the school is going to take some steps to force cooperation fully, so people do not park along Sellers in the afternoon picking up students We've met with Bob Shireman of West Clark Schools to discuss the school bus routing, and he had indicated their preference for the school busses is that they come up Utica, go down Schellers, drop off and pick up the kids here at the intersection of St. Paul, and Schellers, and then exit out and around that away. He siad he can't guarantee that that's what is going to be done for sure. He said one of the problems is they come out Schellers onto Utica is that if there are any cars parked along here on Utica which is common that the busses have extremely difficult time making the turn and sometime they even have to back up in order to make the turn. He said that sometimes they even have to back up in order to make the turn. One thing that we would suggest that be done is from the daycare building to the corner of St. Paul Street, be classified as "No Parking" from 1 to 3, when the busses stop to pick the students up. He siad there are from 3 to 6 busses a day that come by and they don't all come by at once to pick up and drop off kids. I know one of the issues that have been made is the emergency vehicles responding and I asked Mark Ball to address that issue for us.

Mark Ball stated ok, Thank You, like I said, I'm not really asking the board to close the street, I'm here to try to clarify some questions as far as emergency vehicles responses. We do not use St. Paul Street for our response. Our location of our station has us on Utica Street, which we come straight up to Schellers, turn right. If Schellers would be blocked we would be using Sellers Avenue, which give us complete access to there. If that roadway would be blocked we could still use Hauss Street to Oak Street and back through

there. Like I said, to my knowledge, 30 years, I've been driving Police Cars, Fire Trucks and Ambulances, I don't ever recall using this street. But I mean if you are going to go ahead and allow this process whenever the school is open, you're going to have a congested area there with traffic and then you are going to have a problem. But as far as causing any problem for the emergency vehicles by closing that street, it's not going to cause us anything there because we're not going to use it anyway, regardless which way you go. Thank You.

President Broady stated Thank You Mark.

Francis Conroy stated Thank You Mark, I'd like to ask JoAnn Kime who is chairperson of our Parish Council.

Mrs. Kime stated I'm just here mainly to mediate we are only concerned with the safety of our children. As responsible adults we feel like it's our job to do everything we can to make sure our children grow up to be adults. Children don't always show good judgement, sometimes in spite of any supervision they are going to dash out into the street. Adults don't always have control of their cars and that is particular a bad corner. So, if someone is taking a shortcut through there which happens quite often, to beat the traffic that is being backed up now and will continue to back up because of the roads in the area. They are taking a shortcut to beat the light. They really can't tell until they have turned on the street that someone is in that street or not. We feel like that with the extra 4 feet that is widening the street that this will give plenty of vehicle maneuverability to any vehicles that have to go through there. So, on behalf of St. Paul's I'm just asking everyone to please vote yes to close the street. Thank You.

Francis Conroy stated I'd just like to ask Kenny Rush who is a school board member from St. Paul and a member of St. Joe Hill.

Mr. Rush stated Thank You, good evening, my name is Kenneth Rush, I represent St. Joseph Hill Parish on the School Commission. I want to Thank you for letting us come before the board to ask for the street closing and as you've heard before it is a extreme concern to everybody at the school. Right now I would like to present to you some petitions. This petition here is from 7 residents that have signed that are in favor of closing the street, this petition here is from basically from all of the parents of all the students at the school. I think everybody in the school signed the petition. One of the main things I'd like to stress that we're not by any means here to dispute the fact that there will be some minor inconveniences when you do close the street. Our major concern is the safety of the children, the safety of our 282 students that go to St. Paul. So, based on that fact we're here to ask for your support for the street closing. Thank You Very Much.

Francis Conroy stated Ann Marie Galligan will talk for us some.

Mrs. Galligan stated as you know I'm usually on your side of the table, so I'm here tonight to do a few things that people do to me all the time. I've been a member of St. Paul's, Parish for probably 15 years now. My kids went to St. Paul's, they are now Providence, they made it through. But, one, a couple of things I want to touch on with you. First of all, the liability aspect, I'm not sure how many cases you've received in tort action in the town, but Indiana Law changed a few years ago, if something were to happen on St. Paul Street I promise you the town would be sued along with St. Paul's and along with everybody else in sight. And one of these problems is you know, as a town

you have what is called contributory negligence with children it is much more difficult to make that defense because children don't have the judgement that adults have. So, you're setting yourselves up for some problem's knowing that there is a problem on St. Paul Street. I will tell you that when my children were in schoool at St. Paul's we didn't have the activity center on the other side of the street. There was always a Police Officer at the corner of St. Paul and 31 when school opened and when it let out. Now I understand that is not able to be done anymore because Sellersburg is growing and the Police force is not growing enough to provide that officer there. But that' just one indication of how dangerous that intersection really is. For many, many as years my children went to school there was a Police Officer there. I would certainly ask that you all keep in consideration these, there will be a small inconvenience for people who live there very close to St. Paul's Street. But, that is of course nothing in comparison with the awful loss that would be for some parent or for the rest of the community if we lost a child there. Thank You.

Francis Conroy stated I'd like to ask Fran McTustely the school principal to address the issue of safety concerns and the students going back and forth.

Ms. McTustey stated Hello, I'm Fran McTustey and I'm principal of St, Paul and I've been at St. Paul's for over 20 years, both as a teacher and as principal. Tonight I'd like to tell you about 2 incidents that happened just recently at school. One was with a little first grader, who was just getting on his bus and was almost hit by vehicle speeding around the corner of St. Paul's Street. I think if it wouldn't have been for one of our supervisors that was screaming to get our little one's attention that we probably would have lost him and that happened 2 days before school started. Another incident that was involving a motorcycle and this was shortly before school was out as well, and the motorcycle we think was using St. Paul's as a shortcut. We've seen a lot of traffic coming around St. Paul's recently to avoid the highway travel, the highway traffic. And in this case the motorcycle once again nearly missed two of our children. This too was when they were borading their school bus to go home. We have had a few of the activities in the new building in the month of May just to kind of have a taste of what it would be like and what we saw was our children really don't see that as a street. They are so excited about the new building they just think that's their school, and they just go even though we do have a lot of supervision. We always require at least two or three adults to be with the kids at all times. Children, being kids, they are just looking at that's my school and I'm going. It's not in their minds that that's a real dangerous street there. So, we just ask tonight that if you would just please consider just closing this little piece between the two buildings. The street bisects our campus now. When school starts we'll estimate from 800 to 1000 students crossings per day and that's, some of our kids will be going back and forth three and four times at least, given the many things they will be doing at the schoool. Last year, unfortunately during the summer we lost one of our little ones in a horrible traffic accident. We know the heartbreak, we know the pain that this can cause to families in the entire community, and that's why we're here tonight, just asking before this happens again, please close the street for us.

President Broady stated Fran how many students did you say would be crossing daily?

Ms. McTustey stated all of our students use the new building. Now, we will have grades K-2 in the new building, but we'll have PE in the new building and we'll have early morning gathering in the new building, we'll have dismissal in the new building. So, all of the students will be going back and forth across the street. We have computers in the old building and we have other things like that where the kids will have to go back and forth.

We have lunch over in the basement of the church still. So they will be using all the buildings constantly throughout the day. And so we're just real concerned about the safety of the children.

President Broady stated Thank You.

Father Richart stated do you have any questions of us Dave?

President Broady stated does any of the board members have any questions? Is there anyone here that wants to talk in opposition to it?

Mr. Cook stated yeah, I want to tell you why we don't want it closed. I live on the corner down there, years ago, I've been there 45 years, and whenever there wasn't a holy day at St. Paul's there wasn't a guard there. Our kids had to walk across 31 by themselves. Now, that's the truth if I ever told it. The only time there was a policeman there was when they didn't have a holy day. And as far as the kids getting hurt, there is 80 kids, twice a day walks down our street going to the pool. They've got people with them. On one occasion they got to Oak Street, they were two or three cars sitting there they had to wait until them kids got across the street. And then on top of that when they put them cement barriers up, when they put the brick on St. Paul's School they put a wall out there where we had one way traffic, you all are aware of that, right? Alright all the kids that had to walk there they had to go out in the street to get to the high school. And they don't think our kids are in danger. I feel for the kids too, but our kids are just as important as theirs are. And if you want to close the street, it's up to you people but I jsut don't think you should.

President Broady stated ok, you have a petition there with some names on it or?

Mr. Cook stated and I also have been told that some of the people up there in the traffic jam they said why do they want to close that street? I'm mean they are officers. Said 45 people out of 50 are St. Paul using that street. And that's the truth, 90% of the people that come up there are St. Paul people and on top of that, all these kids that voted to close this street, I was told they had to make a grade and they wanted them to stand out there, they had to get a grade on it. Now you think that's right, bribing these little kids here, I don't think it's right. That's what we were told, and I can prove it with some of the people and they are Catholic.

President Broady stated ok.

Mr. Cook stated bribing little kids in grade school to sign a petition and I also heard that some of these live out towards St. Joe, are they paying city taxes? No, they are no, we're the ones paying the taxes up there and that's all I got to say. So, it's up to you people.

President Broady stated ok, Thank You Mr. Cook.

Mr. Cook stated here's some papers I got I want you to look at. We even took pictures at certain times of the day. Right here you can see, it's kind of hard to see these kids right there. But there was no traffic on that street. And they didn't have no parking right there. But whenever you have bingo, two nights a week when they come in they go out St. Paul's Street onto 31. That's the way we go. And when they built it, who do you think

used that street, all the semi-trailers. All the trucks that come in there, all the dump trucks, which street you think they used? They used St. Paul. And then 4:30 in the morning they was out there pouring concrete.

Mr. Cook stated and we had lights shinning in our bedroom window. We had these beepers there to keep up awake, 4:30 in the morning. We lived in dust from September till they got it done. So we have got a gripe going. That's all, Thank You.

President Broady stated ok, anybody else want to talk in favor or against?

Penny Dean stated my husband couldn't be here, he's out of town on business. But, he had some points he wanted to make and he asked me, ok? When the issue was brought up it was decided that the street would not be closed until it was agreed upon by the residents. We are the residents, it didn't say the church people, it didn't say the children, and it was for their safety. No one from the church has ever come and spoke with us regarding this issue, and Ken, I'm sorry...

Council Member Alexander stated you don't have to be sorry.

Peggy Dean stated you shouldn't be allowed to be voting. Ken has other interests in the church, do you have a wife?

Council Member Alexander stated nope, I ve got a wife but not in this parish.

Peggy Dean stated not in this church at all?

Council Member Alexander stated no, sorry.

Peggy Dean stated my husband wrote this, so I...

Council Member Alexander stated I have a sister-in-law.

Peggy Dean stated a sister-in-law, so other interests.

Council Member Alexander stated I have relatives all around Sellersburg so I was hoping none of my voting, for my record had nothing to do with all my relatives.

Peggy Dean stated ok, he goes on by saying he understands there is a petition with 400 names on it. How many people did sign the petition actually live in the neighborhood that will be effected? For what it is worth I could go to Louisville and collect thousands of signatures saying to keep the street open. But, that would have no effect on who signed. We have signatures of people who will be effected. Ok, he does say the church pays no taxes, I don't know why he said that. I've been there 38 years and been paying taxes that whole time. My family has been in the same house for 100 years and we've actually paid for the street over and over again. There was report in the Courier Journal that there had been two near misses of children being almost hit by cars. Who is watching the children? You all said there is always somebody watching the children. If they are getting on the busses, those busses should have stop signs, those people should be stopped. To the best of my knowledge, there has never been anyone injured by an auto in the subdivision. Therefore, if the parents would drive a little slower picking up the children it could reduce the danger to the children. When there are no parents

picking up or dropping off children the traffic on St. Paul's Street is good. There are two other forms here; so bear with me. Why has no one come up with any other options to closing the street, for example: There could be a crossing guard, or there could be signs posted that there are children present, or the school could have the children picked up inside the old playground. There are many ideas that hasn't even been explored yet. This is such, and I don't know what he means, this is such a blatant attempt at subordinating the wills of people by elected officals who incidentally will be replaced by new electric. I'm just reading it, ok? Let's let it go now and discuss it no further. I don't want my street closed. I think there are other alternatives that we could come up with. And when you guys told us the last time we were here that what the residents want, yes, no, are you changing your minds? The residents still didn't want it shut. There's got to be another alternative. Thank You.

Mrs. Kime stated excuse me, I do want to point out to you all on your petitons I think the petitions are highlighted in such a way, or they are segregated in such a way to show you those who signed that actually live in the neighborhood and those who signed who do not live in that neighborhood.

Resident stated right, the one's who voted in favor of closing our street are in blue.

Resident stated can't here you.

Resident stated the one's that voted in favor are shaded in blue.

Council Member Fenner stated on this petition here?

Resident stated their houses are shaded in blue.

Council Member Fenner stated ok, I understand.

President Broady stated anyone else got anything to say?

James Kent stated yeah, my name is James Kent, I live on Sellers Avenue, I am affirmily against closing that street. Already the traffic has picked up on our street very, very much. Sometimes I have, the other day I counted 21 cars in the morning, at one time till I could get out of my street, out of my drive. The trucks is going to be using that street, it's already a bad place down on the corner of Utica and Sellers, getting in there with the trucks. They come down there, our kids and our grandkids are just as important as those kids that go to school. We have kids out there, and they talk about almost near misses out there. The next door neighbor, has two little boys and one comes down, and they drive when they come down to pick up those kids like they are in the Indianapolis 500 or something. That little boy stepped out in front of the street and he almost got hit by one of those parents that picked up the children right there. I don't see why that they don't take the alternative, instead of closing that street, why they dor put an overhead walk across that street or something. The busses could get under it, the cars could get under it, and you wouldn't even need a guard if they put a fence on each side of that street there and have a crosswalk. Thank You.

Resident stated I don't know how much you all have had to deal with Americans with disabilities lately, however, I don't think it's possible, in that spand to make a crossing that would pass muster under A.D.A. can't use steps, you have to have a certain grade and

you can't get that grade in that short of space. So, it's not possible under A.D.A. to have a crossing like that for this particular space.

President Broady stated anyone else?

Mark Carter stated yes sir, my name is Mark Carter and I won't face the board. I live there right on the corner, my house is probably most effected by this closure. I guess the biggest problem we all have is safety. Safety is what concerns all of us, I mean I live there and the first thing is said to my kid is you can't go outside you'll get run over by the cars. And in the afternoons whenever and watch the people leave the school picking up the children, believe me, there is no...in my mind whenever you see a mom in a caravan with 3 kids yelling and screaming shooting around that corner. You know, I guess the thing is, it's not so much that I'm against the church and school. It's not them against us, I think there would be a more viable alternative. I know that they have been kind enough to show us a map. But, don't you think it would be easier to attack it from the intersection, the highway than just to close the street? A caution light, maybe some signs along the highway. The biggest problem you see is the 24-7. The people are going to want the street closed all the time all day. The school is only open and oprerating during peak hours, some of the peak hours during. I mean, can't there be a viable alternative to work out the difference? So, let's not close the street.

President Broady stated anyone else?

Leland Joyce stated I'm Leland Joyce, I live on Lisa Avenue. I've lived there for 34 years. My children went to school at Sellersburg and Silver Creek. I would like to say, I'm not in favor of closing the street. There has got to be an alternative to work around. I come home from work in the afternoon and if I get home at the time that school is being dismissed I cannot turn off of Utica Street onto Sellers Avenue to go to Lisa on the count of the oncoming traffic. They will flat run over you, you drive like maniacs down through there. I'm not criticizing nobody, because everybody is guilty of it. You get out here on the road, you see it everyday. I'm a professional truck driver that's what I do for a living. And it irritates me to no end the way people drive. But, you can ask the people that live there, the will flat run over you. You can't turn in your street, now I go out of a morning, there is no problem. I go out St. Paul Street onto, I can hardly get out on Utica Street because of the cars parked on it. Traffic coming out, a lot of time in the afternoon when the traffic, because I come in late, I come in off of St. Paul's street. But I've always been very careful to watch for children. And I'll still say, there has got to be alternative to closing that street. Thank You.

President Broady stated anyone else?

Mrs. Harold Cook stated as my husband told you, our kids went to school there just like he said, cross over and we never lost a child. But they had to really cross morning and night and they did it, and we didn't ask them to close 31 W. No, I-65 was there, it was bumper to bumper. That was harder, they've got a little short place to cross that street. If there is an instructor there which there is supposed to be just going from building to building and if that instructor can't control children from Kindergarten through 6th grade then I wouldn't want my child even going there. And far as the steps are concerned, I've been up in that building off them and those kids, my grandchildren and everything have run up and down all kinds of steps.

steps wouldn't be a problem for a crosswalk. But, if you can't do that, I suggest a push button signal and paint a crosswalk. That would eliminate a little speed. I just don't think it should be closed. And also, we're all seniors back there and we've got heart attacks, we got strokes, we got high blood pressure people, and if they need emergency that is the fastest way in and the fastest way out.

President Broady stated anyone else?

Mr. Hoffman stated I just want to say about the new building that they built, they got the asphalt in there, we're getting that runoff from that asphalt on our property, all the water is running down. It's up the town now, because they didn't want the expense of doing it, so they give it to the town.

President Broady stated ok.

Mr. Hoffman stated it ruined the beautiful driveway of the people live there.

President Broady stated ok, we're going to move on, yes Mr. Cook.

Mr. Cook stated we'd like to ask how many here of the neighbors oppose the streets? How many are from St. Paul's? How many live in Sellersburg? How many live in the effected area?

President Broady stated real quick.

Mr. Cook stated that's what you call stacking the votes.

President Broady stated there's been no vote yet taken Mr. Cook.

Mr. Hoffman stated the last time the board was petitioned up until now, what has changed is what I'd like to know? Just the building has been built, right?

President Broady stated right, ok, Doug you got something to say?

Vice-President Eddings stated yeah, I think I'm speaking for most of the Board Members up here, it's our personal choice if we close the street tommorrow.

Resident stated we can't hear back here.

Vice-President Eddings stated I think I'm speaking for most of the Board Members up here, if it was our personal choice we would close the street tommorrow in the interest of the safety of the children. And all you people from St. Paul's have to realize that we are elected officials, and we have to represent the people in the effected area. That's not to say that I'm not disappointed with the whole way the situation was handled. I'm disappointed with the way the situation was handled. I'm disappointed with the way St. Paul handled the situation on the project from the get go and I'm disappointed in some of the residents who appear to be against closing the street for no other reason than it's St. Paul. Now, what we need to do is work out a solution. One of the residents said there is no alternative. We've got some drawing and some plans right here in front of us. We got three different alternatives that we'll close St. Paul's Street or partially close St. Paul's Street. Some how or another the residents and the church and the school needs to get together and come up

with an alternative or agrees to an alternative. Because the pressure from the church on the elected officials is going to just keep on and keep on. They are not going to give up on this issue. They are that dedicated on their cause of the child's safety and I don't blame them. If I was sitting in their seat I would be doing exactly the same thing. I have the unfortunate position to be sitting in this seat where I have to do something because I am an elected official. I have the represent the people who are paying taxes that are paying our salaries that are in the effected area. That is my job. And I have to do my dob. Like I said, if it was up to me personally I'd close the street tomorrow. But it's not up to me personally. The people that live in the area need to take strong look at the objectives. The next town board, if this continues, if they keep coming back with petitons the next town board may just vote to close street and you will not get any benefit out of it what so ever. The people from St. Paul's have to realize that the Town Board Members up here are obligated to the taxpayers in the effected area. If the people of St. Paul's were living in a subdivision and an organization moved in next to an organization, whether that be a Fire District, a School District, or a School Building, a Company, a Church or whatever. And that Church decided to expand, it's a good growing organization and it decided to expand, and it expanded and it wanted to take away a benefit from you as a taxpayer, you would be sitting on the other side of the table tonight wanting your Town Board and your Elected Officials to represent you. So, it's a disappointing situation from all ends and I suggest we work out an option because the residents are going to lose in the long run if you don't work out a viable alternative so we can close St. Paul's Street. So, if anyone wants to look at these options, I've got a drawing with all three of them here. I'll be more than glad and sit down and work this thing out right now if you people want to. Ok, option number one is to make St. Paul's Street one-way, exiting out to 31 only. With a traffic Light on 31, caution lights on 31 and signs not allowing entrance into St. Paul's Street from 31 and also school signs and caution light signs with a crosswalk from the building to the new building. That will be option number one.

Council Member Fenner stated are there also concrete barriers to keep people from coming into St. Paul's.

Vice-President Eddings stated concrete barriers to keep people from coming North on 31 from turning into a one-way street. That would be option number one.

Resident stated let me ask you something, these trucks, these tractor-trailer how are they going to be able to go on the one-way?

Resident stated I've never seen a tractor-trailer on there.

Resident stated who said that?

Resident stated I did.

Resident stated let me tell you, you come to my house right after this meeting is over and I'll show you pictures that I've took where you can't even get up and down Schellers Avenue, they have been out there loading and unloading.

President Broady stated everybody sit down, I'll tell you what, you go over these options.

Council Member Fenner stated I guess that's my question, are we voting just to close the road period, straight close the road, nothing else?

And also going to add to our tax base, you are not going to do very much of that. I mean, that's not your fault, it's just the nature of your business, but secondly you're unfortunately you're caught also we're in negations concerning the railroad crossing down there and right now we're not sure where that is going to stand. The last proposal we had was going to cost the town 161000.00 or something like that.

Attorney McCall stated that was the projection.

Council Member Fenner stated that was the projection, possibly and if we're, if there is a chance we're going to have to put money into a railroad crossing down there, then I personally can't support a tax abatement for any business that goes in there. Because they're costing the town money already, rather than helping the town. I mean I hate that but I have to represent the town.

President Broady stated I have a problem with it because it doesn't meet my standards of ne jobs and stuff like that.

WHEREAS, the Town Council for the Town of Sellersburg has heretofore passed and adopted a refuse and garbage regulation for the Town of Sellersburg; and

WHEREAS, the Town Council for the Town of Sellersburg has determined that amendment to said Ordinance is necessary for the effective and efficient administration of Town Government; and

WHEREAS, this matter was considered at an open meeting in which the public were invited to attend and participate.

BE IT NOW THEREFORE ORDAINED by the Town Council for the Town of Sellersburg:

Article 9, Section 6-96 of the Sellersburg Town Council shall be and hereby is amended as follows:

That each owner, tenant, or occupant of residential, commercial or business property in the Town of Sellersburg, Indiana, shall be afforded municipal refuse and garbage collection which shall include the removal or cardboard which has been stacked and tied into a bundle.

Removal of cardboard shall take place on every other garbage pick-up day when there is no collection for yard waste or recyclable materials.

Council Member Fenner stated well I think what Perry is saying maybe we need to negotiate now, before we sign the contract.

Attorney McCall stated well, and I don't know about that because in the letter that Tim sent it basically said that we've got these increases for example one new employee this employee will be responsible for CCT program, collections, maintenance amoung the other jobs. Total adjustment requested 47,184.00. And that seems to me that there are values, and again I'm not trying to make this difficult, but there are value place on what services are being inside the contract because thats what an adjustment is. So I'm saying from the get go everything else is saying from the get go this little problem we've got going on here has not been resolved. I would hope it would be at this point. But maybe you would want to look at that.

President Broady stated what do you suggest?

Attorney McCall stated well, I mean your dead line is not up yet. I mean you don't have to act today. It doesn't start till...

President Broady stated it's not up, but I mean, I want to get it...

Mr. Crawford stated I mean if it would be convenient to negotiate it at a later date, Perr

Attorney McCall stated it said, and I guess thats just advise me on that I think that's my problem that it can be negotiated at a later date. I think we should be able to know right now what where talking about if it happens. It may not happen, it may present itself. But I think it can put a dollar value on that now like these that have been shown is the increases that would help us later on to know exactly where they stood. I maybe making...

Mr. Edwards stated I think what we have to do is set down with the Town Board or committee and negotiate what that value is and then just put an addenum for the contract ware voting on tonight. If in fact that happens this would be the dollar figure. This

What happens if you don't at that particular point on that particular service reach an agreement. Is the contract totally void at that point, is some party have an option to withdraw from the contract.

Council Member Fenner stated we pay you to protect us and give us your advise, so we need to follow it but we need...

President Broady stated well, I have a motion on the floor and I believe it was duly seconded, to approve the contract. Any discussion? It's opened up for discussion, so we either got to vote it down or vote it up or do what ever.

Mr. Crawford stated the next item I have is for a Capital Expenditure request, it's in the water utility. If you recall gentlemen, about a month or a month and a half ago we had an 8-inch water main break at the Stout School. During that time, fixing that break it was brought to our attention they have a 4-inch service line going into the front part of the Stout School. Upon investigation of that, we found that there was a 2-inch water meter inside the school. It has been there since the 1950's. Upon further investigation we found that there was two 2-inch service lines hooked to the 4-inch main prior to the water meter, meaning that, that usage is not being metered what-so-ever right now. And on top of everything else there is no way to shut that line off if there was to be a break from the 8-inch line which is up 31 to shut it off. So what I purpose to do, the quotes that I've got is one: To put a hydrostop valve in the 4-inch main so in the situation if they have a break we can actually shut that line down, two: Is to install a new 2-inch meter outside the building. Before the 2, 2-inch water lines inside the building so that you can recoup your revenue loss there.

President Broady stated is a 2-inch meter going to handle it?

Mr. Crawford stated I would think so, the 2, 2±inch service lines that are prior to the meter right now are feeding 2 individual bathrooms in that building.

President Broady stated ok, this is a request for 3524.86, is this for the new 4-inch value?

Mr. Crawford stated yes.

President Broady stated to go in and shut it off plus moving the meter out and picking up the two lines.

Mr. Crawford stated yes, this is the whole project.

President Broady stated we'll probably get this back pretty quick off the sewer.

Council Member Fenner stated my question would be, you know the school board is talking about major expansion of Stout possibly moving Sellersburg Elementary into Stout. If they do that would it require more of an upgrade than just going to a 2-inch meter to a 4-inch meter?

EMC/TIM CRAWFORD ADDRESSES THE COUNCIL MEMBERS CONCERNING THE MONTHLY REPORT'S AND A NEW TRUCK.

Mr. Crawford stated Thank You guys, the last thing I have this evening, is a for a lack of better words, I'll use out-of-scope expenditure. This expenditure is associated with a requirement mandated by the EPA or the Federal Government, that come's down along with the issuance of the new NPDES permit at the Wastewater Treatment Facility. It is a requirement that is issured, like I said once again, by the EPA for any Wastewater Treatment Facility, of a million gallons or over, in design and it is called Bip-Monitoring test, and what this test does, it gives them and ideal of quality of the effluent that is discharged from that utility on a daily or average, yearly average. The test is performed over a 3-month period. One week out of each month, and it has to be done by an independent laboratory. The two laboratories that I have listed in front of you are both approved by the stated and the EPA to perform these tests.

Vice-President Eddings stated this takes one time a year?

Mr. Crawford stated this just takes each time the permit is issued. So there will be five years before this test has to be run again.

President Broady stated didn't we talk about this at the last meeting?

Mr. Crawford stated no, we did not.

Council Member Fenner stated I don't think so.

Mr. Crawford stated you and I had talked about it, if you remember.

President Broady stated ok, really this is a no brainer, we have got it, right.

Mr. Crawford stated it is a federal requirement. It is just something that you've got to do.

President Broady stated this comes out of the Sewer Department?

Mr. Crawford stated yes.

President Broady stated ok, I'll entertain a motion to approve the expenditure of 5000.00 to Commonwealth Biomonitoring, Inc. for the test that are required by our environmental management permit.

Endorsement modifies such insurance as is afforded by the provisions of the policy relating to Communication of the Comm

### I. ADDITIONAL INSUREDS

The Persons Insured provision of the Comprehensive General Liability Coverage Part GBK 082-3 shall also include the following while acting on behalf of or in the interest of the named insured:

- (A) any member of the governing body of the Named Insured;
- (B) any member of boards or commissions of the Named Insured;
- (C) any elected or appointed official of the Named Insured;

So, anyway then about April, when I received the March bill, and it was \$580.00. I had heard that, through the grapevine, which is not a good source, that there was some mistakes on some water readings, so I didn't think much about it and I assumed that the bill would be rescinded. That was just through the grapevine that was not with a notice or anything. Anyway, since that never happened, and then I got this \$700.00 and I realized that it hadn't changed any. Twenty-Five thousand gallons in March and 19000 in April, something like that. I can't understand that.

President Broady stated ok, are you familiar with that?

Mr. Crawford stated what is it?

President Broady stated Denise lives at 242 Broadway.

Mr. Crawford stated have you spoke to me before?

Denise stated what.

Mr. Crawford stated no, it does not ring a bell with me.

Denise stated I talked to the girls in the office.

President Broady stated they are saying you're still using 20 some thousand gallons of water.

Denise stated no, not now, she said it has changed back down to 2000.

Council Member Fenner stated it was over a 2-month period, not a 1-month period that you had the excess usage?

Denise stated the first month was 23000 and the second month was 19000.

Council Member Fenner stated and then it went back down and you didn't do anything to it.

Mr. Richards stated again I guess I go back to understandings that I had in the past, Jesse's understanding too. Resolution 95-28 dealt was given to us at the time of beginning development of the Industrial Park stated that the area was, that our park was a revitalization area. At that time which gave the town designated that for the purposes real and personal property tax abatement and hereby makes us the designation. It does go on to say that the Town Council of Sellersburg does hereby determine that the property owner who qualifies for and is random property tax deductions will be for five years for manufacturing equipment and ten years for real property. Ok, now I guess that the property owner, who qualifies for it, anybody can stand and talk there case in regards for that. Now, Jesse's understanding at that time was and I was not involved in the meeting, is that from the board is that, that was a formality if they wanted development to go, they wanted to increase, and bring additional businesses into this area. We have submitted for the current building that we are building there, but there are some other issues there because of the interpretation of this and based on Jesse's information to me. We have been representing to other people that have approached about locating in that Industrial Park that tax abatements were in place. It was basically a formality once they got it and filled out a couple of pages and submit it. Now, we have recently had one that was rejected, the Sandpit Volleyball Facility that was rejected that I'm going to have to deal with it in some manner, because that is the way it was represented to them based on our understanding. And the other thing is, right now we are in the process of negotiations with a distribution center that is looking to build a 150 thousand foot and the only reason they are looking at us the tax abatement. There has already been core drilling done to test the depth of the dirt and so it's more than just for the facility that we're looking at, we're also looking at interest involved. Looking at an example, the building that we currently own there, and the A-1 Products Facility. The tax structure there is such, we're right now paying 20%, and we're in the third year. We're in 99, and we're paying 98, which was the third year. Looking at that, our taxes this year is a little over 20 thousand dollars. Of that the Town of Sellersburg receives not quite 6200.00. Ok, now that is just the 20% level, now, looking at what the town is going to benefit from this. Somebody builds the same facility, in 3 years they are looking at 6000 if we had thirty of those today, you're looking at \$180.00 thousand dollars. At the time the tax abatement is up, you're looking at \$900 hundred dollars a year. So it's a tool to bring in additional businesses and develop this area which along with it is going to help the restaurants and insurance people that are here tonight. So it's going to be a compounding effect with every business in this area. So I guess at this point we're not just looking for a determination on just this building, but where are we at? I need to let these people know tomorrow whether we stop, just say it's not there for a distribution center. Jesse's understanding, again it was basically whatever located in there would be granted a tax abatement. It is a redevelopment area, it has gone from agricultural to industrial. Again if there is any questions I will be more than glad to appeal them. Jesse is here for things that came before me.

President Broady stated well, I think first of all, making it a revitalization area, it is my understanding, Perry, correct me if I'm wrong, it does, it puts us in a position to give a tax abatement on an individual basis. We have done that to several areas and the other they would, before they started building they would approach us to make sure that, that was something we would give an abatement on. Is that the case? We're not trying to get you all in a bind here, hanging onto the past and misunderstandings, the one you asked for the last meeting is a 30 thousand square foot masonry building. At that time the board wanted to wait and see what kind of building it was going to be.

I don't know does anybody else have any comments? And when we look at the volleyball, what we're looking not just the building, we're trying to give the abatement, manufacturing certainly falls into the category.

Mr. Richards stated also looking at the distribution center, its manufacturing distribution, I mean, a distribution center can also employ a large number of people. So you're bringing in additional jobs. If you look at the tax base, it is based on the value of the building. I mean, as a taxpayer myself, I'm looking for additional ways that I'm not going to be taxed as heavily on my personal property. If we've got additional businesses in the area, their portion or share is going to increase and therefore at some poing and time mine's going to be reduced by the board, the ammoniates are going to be enhanced by additional services by the town. So, it's a plus for the town, by it being manufacturing, manufacturing does add one other thing, it does have personal property that's going to add tax dollars. Well, looking at it from a business standpoint that's just icing on the cake. We feel that the cake is there, that just adds icing to it.

Mr. Ballew stated Dave, you know another thing too, the tax abatement we have down in Clarksville, it's the boards discretion. They can give it on anything. Because all it is, is a business deal to bring the tax base. You are going to bring in more money. We would not have built that building right there today if we didn't feel like you know, we could have sold the A-l building if we wanted to move out last year. And I told Stan let's build this building now, if someone comes in now we can lease it to them or whatever, we done that based on the fact, we assumed that we had a tax abatement and everything. Really it's a business deal. We went with the Industrial Park instead of residential, I talked to Stan and said they'll work with you on a tax abatement because it will get people in and make money. If we get the building and it's going like we think it's going to bring in over a million dollars a year in taxes for the city not, it will be alot more than that. If you figure 35 buildings like we have it's going to be a million-five a year. I know that will be alot of money for Sellersburg. It's a win-win for everybody.

Mr. Richards stated and we're looking at another one tomorrow, building a facility about the same size as the one we're in the process of building now only difference is it'll have a 24 foot u-pipe and again, it's not going to be, we're going to have to make a decision if we're going to put it in our own park ok, and bring the tax dollars in here or do we need to look at places on another one of our properties in another area and where we know that we can get tax abatements where as, if we put it up here it's just going to increase. The more we start getting phone calls, the more we can build there the quicker this is going to develop.

President Broady stated any comments?

Council Member Fenner stated I would say, that we as a council would agree that we want to attract business to the community. We would like to broaden the tax base. We want to see your Industrial Park suceed, you know some of us weren't here in 1995 when this resolution was passed some of us rely on the other council members and our attorney's interruption of that. Whether it was implied or expressed that there was a guarnteed tax abatement for everyone that came in or whether it was on an individual basis. You know my thoughts have always been that it's on an individual basis because I think it would be irresponsible for a council to give someone carte blanche approval not

knowing there nature of the business coming in there. There are some businesses that we may not want to attract to our community. Maybe legally we can't absolutly keep them out but there is no sense in us doing everything we can to get them in here. So...

Mr. Ballew stated there are also certain restrictive coverages on that park to prohibit them from coming in there.

Council Member Fenner stated yes, we're going to count on them also. But still, I think we feel a responsibility that we should have some say who is getting preferential treatment through a tax abatement and who isn't based on the nature of their business or whether or not we really want them, I mean whether or not we want to attract them into our community. You know the other thing that is a concern I stated this when we talked about the, about this one and the previous one and that is, I would really like for us to get the railroad crossing issue settled before we do anything else. That's just hanging out and hanging out there and there's alot of money involved in that settled before we go any further.

Mr. Ballew stated we're working with Perry and them on, and I don't think that's going to be a problem. Nobody wants to resolve that issue more than me you know, we're not going to have a business if we ever have something illegal and degrading to the community. We would expect you guys to say hey, this is fine. We're not going to run something by you because I have more to lose than anybody. And I think you guys are not going to approve something, or to say that it did happen, and we come back to you again and you're not going to like that. The main thing to us is to make money to us and for you all how to get the tax money from that. Which would help the whole community.

President Broady stated this building that is going up now, is that part of the volley-ball, is that the one you're talking about now?
